The west side of the 1100 block of Battery Ave. is improved with two distinct groups of houses, all of which, however, were built before the Civil War. At 1134-1142 Battery Ave. and at 1126-1132 Battery Ave. there are groups of three story, two bay wide, gable-roofed brick houses built in the late 1850's. At 1110-1116 and 1118-1124 Battery Ave. there are two groups of two story plus attic, two bay wide brick houses built by William Webb, a local house carpenter, in 1850. Of this group, 1112 Battery Ave. has since been enlarged to a full three stories in height but still retains its original gable roof. 1106-1108 Battery Ave. is a pair of three story, two bay wide brick houses with shed roof, but no existing roof cornice, built about 1855 with an original gable roof. Finally, at 1100-1104 Battery Ave. there is a group of two story plus attic, two bay wide brick houses, built in the early 1840's.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story plus attic brick house with gable roof was built in the 1850's and formed part of a group of such houses extending along this side of Battery Ave. The house has been covered with formstone.

The house is two and a half stories in height, 11 1/2' wide, and occupies a lot 28 1/2' deep. There is a one story high, one bay deep rear addition. The house is constructed in running bond but the facade has been covered with formstone. The low-pitched gable roof has a two-tier brick cornice. There is a double rectangular chimney located along both the front and rear roof gables on the north side of the house.

Although the original treatment of the door and window lintels and sills has been hidden by the formstone covering, it is apparent that the lintels were flat, either splayed brick or flat wood. All of the window openings are filled with 1/1 double hung sash. A modern flush door is set beneath a single light transom. The house sits on a low basement, the entrance being reached by two stone steps. A square coal opening with metal cover is located to the right of the steps.

STATEMENT OF SIGNIFICANCE

See under 1118-1124 Battery Ave. and 221-223 E. Cross St.

This house was built by Arthur Treanor, a grocer, who also built the two similar houses on the adjoining property at 221-223 E. Cross St. Treanor had his grocery at 223 E. Cross St. in the late 1860's and 1870's.¹ The house was undoubtedly held by Treanor as rental property.


