### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

1622 Baltimore Street is a brick building three stories high and two bays wide. The building is composed of stretcher bond and has a flat roof. The first storey has a storefront window with a cornice. The store is presently operating. In the bottom left is a sallyport. The second and third storey windows have one-over-one lights with flat arched lintels. The cornice of the building is bracketed. The side windows have three-over-three lights with arched lintels. The lintels have two rows of header bond, the top row being slightly extended. The cornice of the back building is decorated with alternating extended headers. This part of the building was probably used as a carriage house in earlier years.

This building, dating from about 1875 is a typical example of Baltimore rowhouses. The Eastlake cornice is noteworthy, its center bracket is a colonnette. The fascia has ornamental jigsaw work.



