DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

1117,1119 Sarah Ann Street is a two storey, four bay brick building laid in stretcher bond. It has a shed roof and a plain cornice. There is a garage door housed in the first storey. The second storey windows have six-over-six lights and flat lintels.

1121 Sarah Ann Street is a brick building of two stories and two bays. The single-leaf door, with an arched lintel of header bond, occupies the center bay of the first storey. The building has a shed roof and a plain cornice. The windows have flat arched lintels. This structure at one time was used as a horse stable. At present the back of the building is caving in.

These three buildings are presently vacant.

This narrow street, formerly known as Harmony Lane was developed in the early 1870's. The neighborhood consists of typical working class dwellings of the late 19th century. 1117,1119, and 1121, presently derelict, were used as horse stables.


