Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This row of four two-story, two-bay wide early Italianate-style brick houses with shed roofs and simple, scroll-sawn bracketed cornices were built c. 1872. The houses retain their original brick facades, which were always painted, but now have been "restored" to an unpainted appearance.

The houses are two stories in height, 11' 6" wide and occupy lots 60' deep. Each house is two rooms deep and there is a one-story back building. The houses are constructed in common bond and were originally painted. Each house has a single hooded chimney located at the rear corner of the house. The shed roofs are capped by a continuous wooden cornice consisting of a crown molding supported by two scroll-sawn end brackets (for the four houses) and decorated with small scroll-sawn modillions set against a plain, deep frieze area.

The tall, narrow window and door openings have splayed brick lintels and wood sills on the first floor, flat wood lintels on the second floor. Colonial-style wooden door enframements have been added to three of the houses. These houses also have 6/6 replacement sash and modern six-panel doors. 314 S. Otterbein St., however, has 1/1 replacement sash and a plain modern door. The houses sit on low basements, the entrances being reached by one or two concrete steps.

Builder/Architect

Prepare both a summary paragraph of significance and a general statement of history and support.

This group of houses is significant in that it represents the level of architectural stylishness achieved by many builders of small street houses in the late nineteenth century. The houses were built according to a pattern that was quite common to the city's working class neighborhoods of the period c. 1870 to 1910. Recognizing that workers held different levels of jobs (and pay), builders created a hierarchy of house sizes (and prices) in the new neighborhoods going up to serve the expanding factory districts ringing the harbor and northeast and southwest of the central city. Builders acquired anywhere from an eighth to a half of a city block and built 14' x 15'-wide three-bay-wide, two-story houses on the main streets, and smaller, 11' to 13'-wide two-bay-wide, two-story houses on the narrower streets bisecting the blocks. Typically, in this period, main street houses might sell for \$1,200 - \$1,500; small street houses for \$700 - \$900.

Occasionally, the builder retained ownership of his small street houses to provide income for himself as rental properties. In this way people of varying means could afford to live in the same block. If they couldn't afford the purchase price of the small street houses, then they *could* afford the \$8 or so a month it would cost to rent one, while they saved to be able to buy their own home later.

The houses are especially significant because of their proximity to the Baltimore & Ohio railroad yards, the nation's first railroad, and its related railroad-oriented industries, like car and rail shops. Housing of this type was built to provide inexpensive housing for the wide variety of both Irish and German immigrants who came to southwest Baltimore to work in railroad-related industries in the decades after the Civil War.
