This district has two inventory numbers (B-5097 and BA-3192) because it encompasses areas within Baltimore City and Baltimore County.

The Westgate District is an irregular-shaped neighborhood located on the south side of Baltimore National Pike (MD 40) between the Ten Hills district and the Baltimore City line, and extends across the city line to include Charing Cross Rd. and Old Frederick Rd. It is a residential district including a variety of homes dating from the first 1910s suburban development in this area to the final filling in of lots in the 1950s. A variety of popular home types and styles are present, including single-family and duplex housing in the Colonial Revival, Tudor Revival, American Foursquare, Craftsman, and Minimal Traditional styles. The majority of homes date to pre-1940, with the earliest constructed ca. 1913. The last group of homes was constructed in the 1950s. In general, the houses are of average size and of higher-end construction, possessing details more distinctive than the average builder home of their era. The frequent use of natural stone, slate roofs, half-timbering, and elaborate door surrounds suggests quality construction. Some of the older homes on slightly larger lots are clearly custom-built, particularly the Colonial Revival example at 606 Charing Cross Rd., built in 1913.

The advent of streetcar transit opened up formerly rural areas at the city outskirts to suburban development. Catonsville had already become a popular area for country homes by 1900, and streetcars ran from Baltimore to Catonsville on Edmondson Avenue. The advent of the elegant planned suburb of Ten Hills also encouraged development of surrounding areas, including the land immediately to the west of Ten Hills on what is now the city boundary. Many white families left their city neighborhoods for suburbs like this one during population shifts following World War I. The phenomenon of "white flight" was part of this suburban growth, as well as a desire for detached homes with more land. This neighborhood, spanning the city-county line, became known as Westgate. Streets within Westgate have different character, depending on when they were built up. Some streets, like Charing Cross Rd. and part of Greenwich Ave., are dominated by Craftsman bungalows and other styles popular in the 1920s, while slightly newer streets, like Stamford Rd., feature Tudor or Colonial Revival duplexes. Each street possesses some mixture of styles and some lots that were filled later than others. The neighborhood setting, with relatively small lots and many trees, has remained intact. The overall architectural integrity of the neighborhood is above average, though there has been some use of replacement windows and siding. Westgate illustrates the progression of an unplanned Baltimore streetcar suburb from the earliest custom homes to spacious 1920s bungalows and Tudors to the duplexes of the 1940s. It is recommended eligible for the NRHP under criterion C.
