Colonel Charles Ridgely (1702-1772) began buying land in Baltimore County in the mid-eighteenth century--a time when the area was expanding and developing into the commercial center of the state. The Ridgely family and their soon-extensive landholdings were to become a part of that development in that much of this land was used to support a lucrative iron manufacturing business, ^{owned by the Ridgelys} the "Northhampton Furnace and Forges". "Northhampton", the tract of land on which the farmhouse is situated, and surrounding tracts provided the wood for the charcoal used to fuel the furnaces.

As much of Baltimore County had been surveyed and patented by 1699, anyone purchasing land in the eighteenth century did so from the first, second or third owner. Therefore, none of the Ridgely land in this area was an original grant. "Northhampton", a parcel of 1500 acres, was purchased by Colonel Ridgely from Ann and Clement Hill in 1745*. The price of the land indicates that much of it had been cleared and useable buildings were located on it, so it is reasonable to assume that the farmhouse was built prior to the Ridgely acquisition.

"Northhampton" and adjacent properties were bequeathed by Colonel Ridgely to his son, Captain Charles Ridgely, forming a 2,000 acre estate**. It was on this estate that Captain Ridgely erected the grandiose Hampton Mansion. The Captain and his wife resided in the farmhouse during the construction of the mansion, which was completed by 1790, the year of Ridgely's death.

The 1799 Federal Tax Assessment evaluated the farmhouse and four out-~~buildings~~ buildings at \$400.


