DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>PINEY GROVE FARM, built in 1932 as a careful interpretation of Maryland or Pennsylvania architecture in the Colonial period, is a seven bay, two and one-half storey stone house with flush end chimneys. Its entrance front faces the northwest hereinafter called north. At its east end, the service wing extends as a two storey hyphen connecting a one and one-half storey five bay wing, its roof ridge perpendicular to that of the main house and hyphen. The roof ridge of the latter, higher than that of the wing, terminates in a stone chimney rising from the ridge of the lower wing.</p> <p>The principal entrance is centered on the north front; it is embellished with pilasters supporting a pediment. 12/12 windows are in each bay and five dormers, each with an 8/12 window, are in each slope of the slated roof. A one storey shed-roofed porch extends across the west end, sheltering two pairs of glazed doors, and a similar porch extends across the three middle bays of the south front.</p> <p>Internally a central hall extends through the house with an open staircase to the second floor; to the west is a single large room, to the east two rooms. Interior planning and detailing like the exterior, is carefully rendered in the 18th century manner.</p>

STATEMENT OF SIGNIFICANCE

PINEY GROVE FARM was the first house designed by Charles Nes, then of the important Baltimore architectural firm of Palmer and Landin, later the firm became Fisher, Nes and Campbell; one of Baltimore's largest and most important firms, which has seen its partners serving the Baltimore and the nation's architectural community by holding various offices in the American Institute of Architects, including that of the Presidency.

18th century in style, PINEY GROVE FARM relates to non-Tide-water Maryland and Pennsylvania architecture because of its rubble stone walls, and in that respect, is closely related to the Worthington Valley region.
