DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

BRISTOL HOUSE is a two storey, five bay gable roofed brick house with a one storey hyphen and wing, the gable roof of the latter perpendicular to the hyphen and main roof. The entire structure was built in 1936-37, carefully designed and rendered in the manner of late 18th century Maryland houses.

Brickwork of the principal (west) facade is of Flemish bond and other walls are of common bond with headers every eighth course. Masonry above windows is supported by jack arches two bricks in height. Roofs are steep and flush chimneys rise above each gable of the house and wing. The principal entrance is centered on the west front; the arched opening is further embellished with paneled jambs, and pilasters supporting a pediment. The 6/6 windows are flanked with louvered blinds.

The plan is an adaptation of a typical 18th century center hall plan with flanking rooms. The principal stair rises within the central hall to the upper floors. Interior detailing, like the exterior, is accurately rendered in the 18th century manner.

STATEMENT OF SIGNIFICANCE

BRISTOL HOUSE was designed by its former owner, Mrs. Eleanor Stewart Heiser, and its builder, Mr. Walter Tovell, to reflect late 18th century Maryland architecture. The steep roofs with the flush end chimneys are particularly reminiscent of such Annapolis houses as the Brice and Paca houses. The doorway is not unlike those of the triple Ridout houses in Annapolis, or of several houses elsewhere in Maryland and Virginia, especially in Alexandria, Virginia. The closeness of the first floor to grade recalls the garden front of Woodlawn, Fairfax County, Virginia. The use of common bond on secondary facades with Flemish bond on the front is an especially accurate late 18th century touch, relating BRISTOL HOUSE to several other original structures in its region, particularly Bloomfield and Welcome Here (Bloomsbury).
