STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Monkton Mills was a post office name , 1848-1883. The mill is standing just below Monkton at the crossing of Monkton and Shepherd Roads. A new cinder-block dwelling is attached to the mill. The water was from *Charles Run. The village took its name from the Monkton Mills of William Wynn, who named them for Monkton Priory in Wales. The village was originally Charlotte Town.

It was shown as the property of John Merryman on both the 1850 Sidney map and 1877 atlas. Also, "Youth Finds Charlotte Town Plan," Sunday Sun, December 14, 1947. The mill was owned and operated by J.F. Schulz according to a Jeffersonian story of January 1940; Mr. Schulz was in the hospital and aged 80 at that time. The mill was owned and operated in 1944 by Arthur H. Deute (d. 1946), "State's Old Water Mills Get New Lease on Life," Evening Sun, June 30, 1944. The atlas of 1877 shows another "old mill", now vanished, on Matthews Road. The stone house adjoining the Matthews Road mill site has survived.

The date of the Monkton Mill is given in the First HABS Report of B.C. Historical Society as 1760; however, the present brick structure must be much more recent. Another theory about the village name is given in Nd. Historical Magazine, 52:248 by Esther Clark Wright in, "The Naming of Monkton Mills," wherein she states that the settlement was named by Robert Cummings for Monckton in Nova Scotia.

An unidentified mill symbol appears at the site on the 1795 Griffith map.

A sale notice in the Baltimore American, March 28, 1839 offers "that valuable estate known by the name of Monkton or more Commonly, Gwinn's Mills, situate 23 miles from the city on Susquehanna Railroad ... including ... mill..."

John Merryman sold to Samuel Miller in 1864. Successive ~~mill~~ owners were Samuel M. Billingsley, 1917; Edna E. and S. Elmer Miller, 1917; Frank S. Shultz, 1920; Robert F. Fahy and wife, 1941; Arthur H. Deute and Jewel Deute, 1942; J. Talbott Kelley and wife, 1947; Charles C. Walts et al, 1948; K. Albrecht and Mary his wife, 1948; and Asbel O. and Hazel D. Fields, 1963.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE	
<p>Monkton Mill is a two storey brick structure on a stone ground storey, the latter being entirely above grade on the front (north) and partly below grade on the back. Three bays in width by two in depth, it has a gabled roof, plain corbeled brick cornice, and 6/6 windows with exposed wood lintels. Centered in the east end is a door in each of four storeys; the hoist beam is sheltered by a small extension of the roof. The deteriorating iron overshot wheel is on the south side; remains of the millrace may be seen above, and the tail race goes under the mill, thence underground is a stone-walled conduit with stone slabs supporting the turf above, to a point of discharge several hundred feet west of the mill, behind the Miller's house.</p> <p>Bricks are in common bond, with every seventh course headers.</p> <p>The entire interior is framed in straight sawn material, all exposed. A girder, supported by chamfered columns, parallel to the roof ridge, supports the joists, which span from the south wall to the north. Each storey is similarly framed. In the northeast corner of the second storey (the first brick storey) a small office is partitioned off, fully lathed and plastered. A single-flue chimney rises from this corner. Lathing is circular sawn, attached with cut nails. Rafters, exposed in the fourth or attic storey, are half-kapped and pinned at the ridge.</p> <p>Some of the mill's works survive, in situ.</p> <p>The Monkton Mill is one of several brick structures in Monkton, all of similar construction, and probably dating from the same period, conjectured to be in the decade following the Civil War. The most obvious similarities are their brickwork, their exposed wood lintels, and their 6/6 windows.</p> <p style="text-align: center;">James T. Wollon, Jr.</p> <p>The Miller's house is a rectangular two storey brick house above a high stone foundation, three bays in length, one room in depth. A one storey porch extends across the principal or east front, facing the mill, at the first floor level. An un moulded four-panel door is centered between 6/6 windows with louvered blinds and exposed wood lintels. In its detailing, the Miller's House is identical to the adjacent mill, and was undoubtedly built at the same time.</p> <p style="text-align: center;">James T. Wollon, Jr.</p>

STATEMENT OF SIGNIFICANCE

The Monkton Mill is an old structure of rather questionable origin. There has been much conjecture about its origin and although at present time it would appear to be of middle 19th century, there is some evidence that it dates from much earlier period.

The Mill and Miller's House are on lot number 70. This land was leased from Thomas Brerewood by Jacob Bull and in the lease it calls for the construction of a grist mill. (-1) This land passed through many owners and in several of these titles, a mill is mentioned. (-2)

In the 1823 Baltimore County District 5 Tax Assessment the property is listed in the name of John Merriman of Benjamin and the Mill is valued at \$500.00.

In the will of John Merriman, the mill is specifically designated. (-3)

On the 1850 map of Baltimore County, this structure appears on the map and is designated as the Grist Mill of J. Merriman. This would be John Johnson Merriman to whom the mill was left by the will of his father in 1848.

The mill standing on 6 acres of ground, including the mill, dam, mill race, tail race and so on, was purchased by Samuel Miller from John J. Merriman in 1864. (-4)

In 1885, Samuel Miller also bought 14 square rods of property containing the Miller's house from John W. Merriman, (-5) the son of John J. and grandson of John Merriman of Benjamin.

From this, the exact date of origin of the Miller's house is not clear, but it seems certain that there was a mill in existence on this site from the time of John Merriman of Benjamin who built the Partridge House and probably the mill, which was on the same property. It would seem that the stone foundation of this structure has been there for some time and because of its construction, cannot be dated. The brick is more recent than the 1867 newspaper advertisement, (-6) and possibly was put on in replacement of the frame construction. The presence of half lapped and pegged rafters suggests that the roof might have been reused from the elder structure.

According to the newspaper advertisement of 1867, the frame dwelling and sheds were erected in 1851. This would be three years after the acquisition of the mill property by John J. Merriman, the son of John Merriman of Benjamin, the probably builder of the mill.




