DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

37-39 Main Street is a brick and frame commercial structure facing the street to the west; it dates from ca. 1900. Five bays in length, two stories in height, its street front is stuccoed and a one-story display window projects forward beneath a low pitched hip roof across the southerly four bays. Above the 6/6 second story windows the large cornice projects above the nearly-flat roof and it is supported by scrolled modillions grouped between similar brackets which mark each bay.

The brick structure is three bays in depth and another four bays extend the structure to the east; the first story walls of this easterly section are recessed behind the plane of the frame second story walls.

Within are large spaces for merchandising and storage. The front section has oiled wood floors and wainscotted walls; the second floor is supported by two rows of wood columns and beams. An open stair gives access to the second floor on the north side; its moulded rail is supported by square paneled newels and turned balusters rising above a closed string. The rear section is the warehouse, its circular sawn framing joined with mortise and tenon. Approximately centered in the rear section, immediately adjacent to the brick section is the hoisting mechanism of a hand-powered lift; above a large trap door in the second floor is a large iron and wood wheel, iron gears and a large axle-spool.

Falling grade allows a basement or ground story beneath the rear portion of this structure and the front portion is unexcavated save for a space for a former floor furnace and an access trench to it. The first floor framing is all circular sawn, supported by stone foundations and piers.

Present building dates from ca. 1900

Mary W. Flory sold property to Anna M. Vansant and her husband in 1895 (IMB212/451)

Anna Vansant's husband died in 1910

She sold property, including this parcel to Arthur Uhler in 1912 (WPC 397/582)

Mr Uhler ran a hardware store there

At one point the fire company kept it s engine there

Mr Arthur Uhler sold property, including this parcel, to Lewis Caltrider in 1918.

(WPC 504/423) This was a Deed of Assignment.

Lewis Caltrider, in 1930, deeded to George Caltrider 76/100 of an acre which contained this building. This, too, was a Deed of Assignment (IMcIM 847/22)
G. Caltrider also bought (through a Merger Deed) adjoining land from Rebecca J. Stock(s)dale in 1931. (IMcIM 881/315) The Stock(s)dales had bought this land from Charles Flory in 1868. (EHA 59/154)

George Caltrider died in 1959. The Administrators of his estate were C. Dalmar Haynie, Paul Martin and the Maryland National Bank. They sold part of the property for \$25,000.00 to the Arrow Investment Company in 1964 (4265/617) It was now .66 of an acre.

Arrow is the current owner of the property.
