The 200 block of W. Joppa Rd. exists within a neighborhood that is particularly rich in 19th and 20th century architecture. It is a transitional zone between the commercial and strictly residential areas of Towson and one finds a mixture of both residences and offices in these houses. This building is one of those which has been converted into offices but it has not lost its original character.

That the duplex house has had an ongoing importance in Towson is proven by this turn-of-the-century building. The exterior features a porch, brown wooden shingles and spindle-type hood brackets, all of which give it a Victorian flavor.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Although it is described as a single structure, this two story frame duplex is divided into two longitudinally oriented houses. The shingled sides extend four bays in width and five bays in depth, and are topped by a gable-end roof. The foundation is beveled formstone block.

The gable end of the north facade, or main facade, assumes the appearance of a pediment vented by a pair of 1/1 sash windows. The deep eaves have tongue-and-groove soffit.

Two pair of steps consisting of six treaders and seven risers lead to a full porch which extends the first story to the north, is enclosed and divided by a shingled railing, and is supported by formstone piers. The roof, which has a sky blue tongue-and-groove ceiling, is supported by doric columns.

Each half of the building has a pair of 1/1 sash windows on the second story. Entrance doors occupy the inner bays of the first story and a pair of 1/1 sash windows occupy the outer bays.

The northernmost bay of the west facade is nearly windowless, however there is a cellar entrance. There are two 1/1 sash occupying the central bays of both stories and a single 1/2 sash occupies the southern bay. The central and southern bays are divided by an interior flue chimney which exits the roof in the form of a rock-face formstone cap nine blocks high.

The south facade displays a regular fenestration. The first story is covered by a full porch, the center 1/3 of which is enclosed for a pantry space. The outer thirds are open but covered with a shed roof with a tongue-and-groove ceiling and enclosed with paneled railing. The tongue-and-groove flooring of the porch itself is reached by three wooden steps, and is supported by formstone piers.

The east facade is unlike the west in two ways, First, there exists a 1/1 sash window in the northern bay and second, the cellar entrance is covered by a hipped-roof hood with spindled brackets suggesting tracery. This roof is supported by thin columns and the tongue-and-groove ceiling is painted blue. There is evidence that a roof of this nature existed on the west facade as well.





