

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

There are two primary reasons for seeing this building as significant. One is that its oldest portion may be part of the old Towson National Bank and the other is that the liquor store itself has both architectural and historical interest.

Robinson's may be seen as consisting of two distinct parts. The eastern portion is the older of the two and is constructed of stone. On the exterior of the south facade one can see coursed stone with beaded grouting that is colored to look like sandstone (repointing?). An interior flue chimney with a brick cap can be seen here as well. This older portion of the building is only a single story in height although there is a full cellar. The walls of the cellar are made of very rough uncoursed stone. The distance between the joists and floor is 7'. The cellar, like the main level, consists of an old and new part. The old part is characterized by its odd shape caused by the obtuse angle in the north wall.



The break in the north wall corresponds with the odd shape of the adjacent movie theatre and is some evidence that the movie theatre was built around this building at a later date (see current tax map 70A).

In the cellar one can see transverse joists (circular sawn) that are 3" thick and 12" wide. They are lap joined to a longitudinal beam measuring 8" x 8". It is supported in part by a centrally located brick pier. (cross-bracing along the south wall contains wire nails). The wall dividing the west end from the east is 22" thick and is an original end wall (construction of the liquor store extended the building c. 12' to West).

On the main floor of the stone portion of the building there is little original fabric although a nice pressed-metal ceiling remains. The pattern is that of inset squares with a simulated egg-and-dart cornice. There is a skylight in the single room of this portion and it contains the same pressed-metal pattern only in a reduced size.

The title search, structural analysis and early photographs of the Towson National Bank suggest that this older portion of Robinson's is a survivor of that 1880's Romanesque Revival building.

The newer portion of Robinson's is noteworthy as well. One of the major events in United States socioeconomic history was the era of prohibition

which lasted and perhaps characterized the 1920's. It was repealed in the 1930's and Robinson's liquors was built not long thereafter. Robinson's was designed as a liquor store, a type of building which probably had not been designed much since the end of World War I and which exhibits stylistic elements peculiar to its period, namely art-deco.

The exterior of the shop is exposed only to the street. This west facade has an ochre colored corrugated brick veneer. It is characterized by its parapet (one of several in Towson) and a glass sign incorporated into the wall which says "Beer, Wine, Liquors" spelled out in typical art-deco lettering. A smaller sign above this one identifies this building as the location of a wholesale liquor dealer.

Opaque peach colored glass frames the entrance along with aluminum trim. These materials give the facade the machined glossy and streamlined look that art-deco promotes. Immediately above the door, which is flanked by display windows, is a glass panel with sculptured letters that are 16" high and spell "Robinson's." A later, but antiquated, neon sign with the same information is suspended over the entrance at a 90° angle to the building.

The entrance has side lights that contain frosted glass with deco patterns incorporating motifs relative to liquor (bottles, etc.). The interior is typified by the blind wood paneling throughout and the built-in recessed shelves and display cases. These geometric recesses are part of the rounded and streamlined appearance of the cornerless room. Stainless steel (polished aluminum?) trimming helps celebrate the grand age of technology as much as the liquor motif of the entrance celebrates the end of prohibition.

INTRODUCTION

The three recordable buildings in the 500 block of York Road on the east side of the street are problematical not only because of alterations but because of additions and the degree to which buildings share foundations, walls, etc. These buildings were erected in the late 19th century and early 20th century on an historic site.

The history of the entire block is an interesting one. On the 1853 Zur Horst map one can see that the "Hotel" occupies a trapezoidal lot bounded on the West by York Road, on the North by Joppa Road and on the East by Hillen Road. A five acre lot being offered by Benjamin Payne as a possible site for the new Court House lies to the South. On the 1877 Atlas it can be seen that much development took place during the next twenty-four years or so after 1853 including the laying out of streets and lots in a gridiron plan with a North-South axis. The hotel, however, remains on its large irregular lot which forms nearly an entire block and it appears to be using all of that space except for a tiny parcel on Pennsylvania Avenue containing the newspaper office of W. H. Ruby. In addition to the hotel itself there are several large outbuildings. Deeds and old plats indicate that these buildings included at least the stables necessary for boarding travelers & horses, and a stone springhouse.

In its time Towson has had several hotels and taverns which were logical and necessary establishments in a town that was both a crossroads service center and county seat. The hotel which stood on this site until 1929, however, is believed to have been the oldest having been built by the Towsons in the 1760's. That roads, including the important York Turnpike, were laid out relative to the building's location and that it was an important gathering place for over a century and a half are facts which gave it tremendous significance as a landmark.

By 1898, however, the hotel no longer dominated the large and centrally located lot. The Bromley Atlas of that year shows that in addition to the little newspaper office two other larger buildings which had their own outbuildings were constructed facing York Road. The southernmost is labeled as belonging to J. German and the northernmost is Towson National Bank. Parts of these buildings are believed to remain today being contained in Robinson's Liquor store (Bank) and the Kent Lounge. By the time of the 1920's America had become "motorized" and Towson had become suburbanized. Hotels, at least outside of the city, gave way to motels or "motor courts" as they were first called. The landmark which had dominated this block and which had indeed helped to foster the town itself was razed in 1929 and replaced by a movie theatre and shops.

Little or nothing remains of the era in which this block was one of Towson's open spaces occupied only by the necessities of the hotel except, that is, for the irregular shape of the block itself. The only open spaces are the asphalted parking lots behind the more than twenty commercial structures of the block. There are two buildings which were late 19th century neighbors to the hotel and along with the movie theatre are the only structures of the block currently being recorded (1977-78).





