

4 W. PENNSYLVANIA AVE.

The first block of Pennsylvania Ave. has witnessed an evolution of land use typical of Towson itself. The street was laid out in the middle of the last century as part of the courthouse town and was sparsely occupied by residences. By the 20th century there were numerous residences plus some semi-commercial activity as well, although the two story scale of the street was maintained until the 1960's. All through this century residential structures have been used as professional offices. The need for office space, more parking, shops, restaurants, etc. has ultimately resulted in the destruction of residential structures. They have been replaced by asphalted lots and high rise structures and with them came a severe disruption of scale.

At the moment this two story frame house is still being used as a residence and although it is probably less than 100 years in age it has become an antique, for its materials, size and use. That it was moved onto a "back lot" from the street in order to accomodate commercial construction and that it appears lost in a group of larger buildings is symbolic of a trend of land use.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The residential scale of the first block of W. Pennsylvania Ave. is maintained by the several structures that are nestled in between the two highrises on that block, however, only one structure continues to serve the only purpose for which it was designed. That building is the small frame house on the property of the Elk's Lodge. Although it is not on its original site, the house has always been, and continues to be, a residence.

According to the present tenant the building, once faced Pennsylvania Ave. and existed as part of the streetscape of the north side of the street prior to its being moved to an adjoining lot in the 1950's. It is a very typical building in many ways, being an example of a kind of house common in rural areas.

The house is two stories high of wood frame construction and may have had a stone foundation and cellar. Modern shingles cover clapboards. It is three bays wide, one bay deep and capped with a gable-end roof. The building has been and is still oriented to the South. That facade has a centrally located entrance and is covered on the first story by a shed-roofed porch supported by square columns.

With the exception of the north facade fenestration is consistent with evenly placed 6/6 sash. Shell-shaped cast iron shutter locks are evidence that there were shutters and they were probably louvered.

A centrally located flue-chimney exits the center of the ridge. The roof is covered with the same large fishscale asbestos shingles as those on the Elk's Lodge and as those recorded on the "Penn Hotel" (Dec., 1977).

The north facade breaks the symmetry somewhat by being windowless in the two easternmost bays although the normal 6/6 sash vent the lower and upper levels of the west bay. An off center, shed roofed, single story projection occupies the easternmost bays of the first level. It is approximately 8' deep and one bay long being vented by a small 4/4 sash window. It is used as a storage area and incorporates into the eastern end of its roof a hood for the entrance of this facade.

Although the main (south) entrance is centrally located there is no central hall as such. Instead, the plan provides for two rooms downstairs and two above with the stairs being attached to the east side of the central dividing wall.
