DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. 45(48), a ¹⁷⁶⁶ crownstone, approximately marks Mason and Dixon's 45th mile west of the initial stone at the northeast corner of Maryland, the beginning point of their West Line. It is one of only 24 original crownstones still standing along the West Line, and the only one remaining along the Baltimore/York county stretch, the other being a replica (No. 50). Because it "was out of the ground and lying on a steep hillside" at the time of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary, it was relocated to the present site a short distance east and uphill in 1902.

The area here is gently rolling farmland interspersed with patches of deciduous woods; but with a residential subdivision (Heritage Farms) developing along the north side of the Line. The site is located about 1 mile northeast of the town of Maryland Line, MD; about 2½ miles southeast of the town of Shrewsbury, PA; at the south lot line of the subdivision, about 500' east of Little Deer Creek; about 800' north of Harris Mill Road; at the base of a large tree just east of a rocky outcropping near the top of the hill. It cannot be seen from any road, nor easily from closeby at any season; and is dubiously protected.

The crownstone, as with all other Mason and Dixon West Line monuments, was quarried and carved in England, of oolitic limestone, cut to stand about 3' above ground, with a low pyramidal top and a rough-cut base. It was reset to stand about 1½' high above ground at the relocated site, and surrounded below ground with a concrete collar. It now stands about 15" high, still firmly set but with the collar partially exposed from hillside washing. It is in fair condition, badly chipped all over the top and corners. It measures about 11¾" wide by about 14" high on the north side facing Pennsylvania; the shield from the Penn coat of arms is quite clear and some fluting and margins remain. The east side measures about 12" wide by about 14½" high above the foundation; most fluting and margins remain. The south side facing Maryland measures about 11¾" wide by about 15" high above the foundation; the shield of the Calvert coat of arms is clear but slightly damaged; some fluting and margins remain. The west side measures about 12" wide by about 15" high above the foundation; most fluting and margins remain. All top corners and edges have been chipped away; planes barely discernible and deteriorated.

STATEMENT OF SIGNIFICANCE (see Thematic Group National Register nomination form for significance and history of entire survey and monumentation)

Milestone No. 45(48), an original crownstone of 1766, is significant primarily as one of only 24 crownstones remaining along the West Line, commonly known since Civil War times as the Mason-Dixon Line, notable for its historical impact and innovative boundary survey methods. ^{monument was reset at a} The/relocated site, established in 1902 further east on the Line, where it still stands to this day. Individually, and as one of 11 original markers along the present Baltimore/York county boundary, No. 45(48) is also significant locally as one of a diminishing number of objects and structures with an identifiable relationship to our colonial heritage.


