**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This house is one-and-one-half stories, stucco over log or heavy timber frame, fine irregularly spaced bays on the entrance elevation with a shake ridge roof. Longitudinal (ridge) axis is north-south. A one-story addition is on the south, with the first bay flush with the larger part of the house; the remaining two bays are recessed for a porch, including the present entry. There is an unused door on the larger portion of the house. The north gable end contains secondary access on two levels. The steps to the upper door (a recent addition) have been removed. Windows are primarily 6/6 double-hung sash.

**STATEMENT OF SIGNIFICANCE**

Construction dates for the house are open, although this is probably the structure which appears on the 1877 Hopkins Atlas of Baltimore County as the "Josh a B. Sumwalt" residence. The neighboring Griggs house (BA- , DNR 136, Patapsco), a much larger and grander building, may also be that structure, and could have been built prior to 1877. The most reasonable explanation for the adjacency of the two structures is that the Smith house was the early homestead, the Griggs house an example of the upward mobility of the Sumwalt family.

The present occupants are descendants of early owners of the property, and are convinced that the structure (in some form) dates from the late 18th century. This has not been substantiated.

DRAFT--JOSHUA SUMWALT HOUSE, SMITH HOUSE

The Sumwalt/Smith house is a one and three-quarters story structure with a two-room plan. It is a log building covered in German siding, it was remodeled in the early twentieth century and covered in stucco. The main facade faces south and has an entrance and four windows on the main story. The three-quarter story has three six-pane windows. On the west gable end is a one-story addition with an inset front porch. The house has a gable roof covered in wood shingles. The west gable end of the original structure has a concrete block flue. From examination of construction details, it appears that the house was built in the early to mid-nineteenth century.

The Smith/Sumwalt house is located on the west side of Hernwood Road, approximately one-quarter mile north of Old Court Road, northwest of Granite in Baltimore County. The house sits at the end of a two-tenths mile dirt lane that runs behind the Nike Base on Hernwood Road. A short distance east of the house is the Griggs House. These houses sit on a slight rise of the land in this gently rolling countryside.

The Smith/Sumwalt house appears to have originally been a four-bay by one-bay, one and three-quarters story log structure covered in German siding. The entrance was in the second bay from the west and had a small entrance porch. Six-over-six windows were in the three bays on the first story and six-pane windows were located on the second story immediately above the windows on the first story. The remodeling that covered the exterior in stucco also added a new window to the first story

of the main facade. This window is a six-over-six pane window located between the two easternmost windows on the main facade of the first story. This window was to light an interior bathroom that was added to the house. Currently on the main facade is a one-bay shed roof covering the entrance. The windows and doors have plain frames with a rounded edge molding. The stucco runs right up to the edge of the frames, except for the modern window which has a board frame around the stucco. The one-story addition on the west end of the house has a three-bay main facade of which two bays are inset to form a porch under the gable roof. There is a six-pane window in the easternmost bay of the addition and a door and a six-over-six window in the porch section. This addition served as a kitchen wing to the house.

The east gable end has a six-over-six window on each story. The west gable end of the main section has an exterior and concrete block chimney flue. The west gable end of the addition has a single six-over-six window. The north facade of the house has a single window in the original section and a single window in the addition. The gable roof has a box cornice on the main facade and an exposed rafter end on the north facade. The roof of the original section is covered in wood shingles. The roof of the addition is covered in sheet metal.

The interior of the structure is very plain with a boxed-in stairway on the rear wall of the west room of the original section. The south room has been repartitioned to form a new bathroom. The west addition was used as a kitchen.

## Statement of Significance.

The Smith/Sumwalt House shows the architectural character of early to mid-nineteenth century residential structures in this region. Although it has been extensively remodeled, the massing, details, and floor plan illustrate the unelaborate designs of many ~~early~~ central Maryland farmhouses. The structure was constructed of log covered in German siding. The one and three-quarters structure originally had three windows and an entrance on the first story with the second story containing six-pane windows located above the windows on the first story.

A previous survey form on this property speculates that portions of this structure date late in the eighteenth century. The exposed areas on the interior do not show any evidence of a late eighteenth century structure as there is use of machine-made nails and no evidence of early hardware. The property appears on the 1877 Hopkins Atlas of Baltimore County as the Joshua B. Sumwalt residence.




