DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The FOWKE HOUSE is a picturesque two and one-half storey frame house of the last decade of the nineteenth century. With its principal facade to the south, a wide steep gable covers a shallow projection to the south, three bays in width; its roof ridge is slightly lower than the principal roof. The main body of the house extends an additional bay to the east. A very short wing, its steep roof parallel to the principal roof, extends to the west from the northwest corner of the main body. A one-storey porch with turned columns extends across the south front and the southerly portions of the east and west sides. The principal entrance is in the easterly bay of the south wing. Typical windows are 2/2 with louvred blinds. A pair of 1/1 windows is in the south and east gables and a single 1/1 window is in the west gable.

STATEMENT OF SIGNIFICANCE

The FOWKE HOUSE is one of four similar cottages in its row, all examples of the very late nineteenth century medieval-revival style, simplified, using traditional materials without ornamentation to achieve a picturesque recall of late medieval and Tudor architecture by basic form alone.

This is one of 5 cottages listed on 1896 Tax Ledger, p. 218, as part of Thomas Janney property. Over the years this has been rental property.'

The Green Spring Valley was a popular summer retreat for city residents. The Green Spring Branch RR with the Stevenson Station near made this an attractive vacation place until the 1920's. This house remained rental property until sold by Osbourne Beall to the present Fowke family in February, 1975.² Since Mr. Fowke's death in 1979, Mrs. Fowke has continued to live in the house.

There have been few alterations over the years.
