DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

- Brinton Woods is located on top of a hill, .6 miles south of fork road at the end of Brinton lane in central Long Green Valley.
 ✓ The address is, 6410 Brinton Road.

Exterior

The house is a mid-nineteenth century, 2 $\frac{1}{2}$ story, Carpenter Gothic Victorian frame farm house with stone foundation. The original front (east) facade consists of seven bays. On the second floor, the third, six-over-six sash window from the north end has been removed. The top floor has a central wall dormer with a two-over-two sash window with rounded head. At the central wall dormer, instead of bevel siding, there are wooden shingles with chamfered corners. The main entrance is located directly in line with the wall dormer and is enclosed by a screened front porch which extends five bays from the south. Above the exterior screened door of the porch is a stained glass transom with the words, "Brinton Woods".

The north and south facades are two bays wide. The north facade contains one of two exterior chimneys, as well as two attic windows on both sides of the chimney. The south facade has the other end chimney which has been covered by the two bay, one-room deep wing and a one bay, one-room deep, enclosed porch addition with a shed roof. The entire house is covered with bevel siding.

Interior

The hall/parlor plan of the original section of the house contains a one-room deep parlor to the north and a central stair hall to the south which leads into a dining room at the southwest corner. The one-room and enclosed porch addition are south of the dining room and the original part of the house.

The interior has been altered and additions have been made but the original fluted trim and random width floor boards still exist on the first and second floor. The original six panel doors on the first floor and the original board and batten doors on the second floor still remain. The chimney and fireplace on the north end is a modern replacement.

Outbuildings

The house stands upon a hill, and its outbuildings stretch to the east and west of the house. The farthest outbuilding (east) down the hill, is a rectangular six by nine feet mid-nineteenth century springhouse constructed with coursed rubble stone that has been white washed. The springhouse has a wooden shingled roof. The next building (southeast) down the hill, is a late nineteenth century bank barn of board and batten construction with a gable roof of standing seam tin and a stone foundation. Above the barn is a smaller vehicle shed also of board and batten construction. Finally, behind the rear of the house are the chicken coops also of the same construction.

STATEMENT OF SIGNIFICANCE

Brinton Woods is located on a hill in the town of Fork, Maryland in the vicinity of Long Green Valley. The house is listed on the 1877 atlas of Baltimore County but was built much earlier around 1849 when it was sold by the executives of Sarah Gittings to Thomas Gorsuch. In 1889, it was sold to Mary Ann Gorsuch wife of Charles Gorsuch who then sold it in 1911 to John B. and Augusta Byer (h&w). In 1917, it was sold to Annie and Marion F. Shanklin in 1928. Stanley Shanklin sold it in 1948 to S. Rutherford Loizeaux who again sold it in 1956 to Bennie Ross and Doris Jones. Finally it was sold in 1960 to George P. and Helen M. Minderlein (h&w) who again sold it in 1969 to the present owners, Douglas G. and Louise Y. Hanson.

The house is significant as being a good example of a vernacular farmhouse in the Carpenter Gothic style. It typifies the "picturesque" period of Victorian architecture in its gracious setting upon a hill and with its Gothic style. Also of significance are the various outbuildings that still remain on the property such as the springhouse, the bank barn(designed to serve the double purpose of barn, ground level and stable basement level), vehicle shed and chicken coops.

Though the farmhouse and its outbuildings do not serve their original purpose, these visable vestiges remain as tangible objects from which to learn about the past.

by far the best -- excellent plan
title search shd. go further back

Remembrance -- Cooke
→ land grant 1773, NOT 1723. Shows in copy of deed attached.
chain of title erroneous. Haile and Hyde owned Dimmit's Delight.
Only Jenkins and George (m. Ellen Jenkins) owned the property
through Wm. Armour Jenkins who tore down the homestead in 1905
and built Remembrance.

Dawson House -- Aiello
chain of title meaningless
milestone is ordinary turnpike milestone
poor plan ... erroneous interpretation ... basic construction
not correctly identified -- orig. details not identified

Hartley House (Welsh) -- Aiello
title meaningless
mill not attached to house
mislocated on map
not brick

Dovecote Farm -- Rowse
not located on Land of Promise, located on Gunpowder (or His
Lordship's) Manor. It is just on the line. Land once owned by
Wilson family who also owned or built Yoder Farm. Log part
may have been Wilson house.

Ambrose House -- Rowse
badly mislocated on map
plan good
shd. mention former blacksmith shop on prop.

Brinton Woods -- Rowse
small wing, hardly mentioned, has chance of being orig. portion
plan might have explained unusual length

Shankin's Store -- Rowse
title shd. go back further than 1909
date of constr. not proven

Denisch House -- Ellicott
pretty fair job of hard house to do
no record of Mennonites as early as 1830
formerly Wilson land. On Land of Promise

Wilson Church -- Ellicott

church does not face Manor Rd.

originally grey, not white. All shutter hardware new. Doorway left of chancel not new (was door for coffins to cem.)

basement dug to install furnace after day of wood stoves

chain of title is for rental house, not church

Glen Arm Station -- MacNeish

automatic signal was not at station, but at Watchbox Hill blind

crossing $\frac{1}{2}$ mile north

plan OK

Glen Arm School -- MacNeish

OK. Inside plan of schoolhouse wd. have been interesting.

Some of these errors are common ones and quoted by owners. Understandable for student to take on faith. Also understandable why titles often confused by those who don't know names and lands of area.

Am sure I cd. not have done better, or in some cases as well. Wollon & Haile are both sticklers. Anyway, thanks again. Best,


