WILLIAM S. KEECH HOUSE

The William S. Keech House is a relatively large brick house that has several features of the Gothic revival. The Gothic's love of natural light and emphasis on vertical lines is evidenced in the bay windows and the steep cross gable. The dormers are also steep gables that jut into the sky. Ornamentation also being characteristic of this style, is shown in the large decorative brackets under the eaves of the roof and in the decoration around the front door (south facade). This house is unusual in that it is brick and has a cross gable. Presently it is one of two brick cross gables recorded in the Towson area in the last year and a half.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

404 Joppa Road is a 2½ storey brick deep eaved gable roof house that has several Victorian features.

The cross gabled south facade, whose fenestration is symmetrical is 3 bays wide with a flat roof porch supported by wood columns and brick piers. There is lattice work adjacent to these piers. The large half wood half glass door in the central bay has 2 arched sidelights and a 2 light arched transom. On each side there is a tall 6 light window. The east and west bays of the second storey have 2/2 light sash windows. There is a 1½ storey wood swell-front containing 3 windows in the middle bay. Both levels have a 1/1 light arched window in the east and west bays that surround the 2/2 light arched window in the central bay. The uppermost storey has wood gabled dormers that sit in the east and west bays which have deep eaves that give a suggestion of a pediment. Two brick chimnies exit the roof behind these dormers.

The west facade of the main block has a 2/2 light sash window in the south bay and a bay window with identicle fenestration as the swell-front of the south facade sits in the north bay of the first storey. There are two 2/2 light sash windows grouped in the south bay of the second storey and a single 2/2 light sash window in the north bay. The north and south bays of the uppermost level have 4/4 light sash windows and the gable houses an oculus vent. One arched basement window is visible in the south bay.

The tow bay wide east facade has 2 basement windows and 2/2 light sash windows in each storey that become progressively smaller from ground up. This gable also houses an oculus vent.

The north facade's fenestration is irregular as it is disrupted by the projection of a 2 storey wing. In the first storey there is a 6 light window occupying the east bay, a wood door to its west and a 2/2 light sash window in the west bay which has a bulkhead under it. The east bay of the second storey has a wood door which is followed by tow 2/2 light sash windows. The back of the dormers are visible from this facade.

The brick gable roof wing is 2 sided and projects from the north end of the house. There is one 6/6 light sash window in the first storey of the north facade. The 3 bay wide west facade has symmetrical fenestration with its sash windows having 6/6 lights. There is a porch that begins at the east facade of the wing and ends at the northwest corner of the house. There are two boarded up doors in the north and south bays of the first storey with a 6/6 sash light window in the central bay. This facade shows an irregular wall seam that is in the middle of the wing's wall. Above this seam is a chimney.

All of the windows and doors with the exception of the front door (south facade) have brick sills, and arched stretcher lintels. Many of the windows have louvered wood shutters.


