LEWIS JOB RIDER FRAME HOUSE

Anyone doing historical research in the Towson area is likely to find references to the Rider family with one of the most frequent in the 19th century being the calling of Joppa Road the "road to Riders Switch". Present day Riderwood was an important stop on the Northern Central Railway in both this century and the last.

There are more physical remains of the several Rider farms than one might suppose since both early and late subdivision has resulted in fairly dense development. Throughout the Joppa Road - Thornton area, however, there are at least one half a dozen or more buildings which are the survivors of a period when the Riders were the controllers of this land involved in both agriculture and manufacturing. This house is one of them and was once part of the Lewis Job Rider farm.

LEWIS JOB RIDER FARM
BA # 1770, # 1770-A

The private residence located at 8026 Rider Avenue has a hen house incorporated into its northwest corner. "With the addition on the front, the building is said to have been a carriage house..." as well.¹

The hen house has a shed roof and rests on a stone foundation. Although covered with shingles, exposed areas reveal board-and-batten siding.

Also located on this property are the remains of a bank barn. The stone foundation which now stands is composed of uncoursed fieldstone. Characteristics seen include loop-end hinges, hwen timbers, and seven evenly spaced doors and windows along the wall which constituted the first level.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The large Victorian residence facing the tracks with its stylized cross-gabled dormer and accentuated vertical thrust hides the older house to which it is attached. The west wing of this large dwelling is an older house which had a North-South orientation. It is likely to have been a dependency to the early 19th century (possibly late 18th century) Rider farm. In addition to the main house, the foundations for two barns, and a chicken house (see BA# 1770) have been found in this neighborhood. Sub-division which began in the mid-19th century has continued until the present resulting in a relatively high density of buildings in this area thus obscuring the rural quality and the relationship to each other which these earlier buildings once shared.

While the Victorian addition (c. 1870's to 1880's) to this house is a valuable building worthy of recording the specific goal of this survey to identify extant pre-Civil War structures resulted in an investigation primarily of the smaller west wing. A single brick wall on the north end of this otherwise frame building, its unusual access to both the second level and cellar as well as its twin entrances on the south side make it problematical.

On the exterior this section of the building appears as a two story frame and clapboard building with a simple gable-end roof. It is five bays wide and two deep. A rather large interior chimney is centrally located but does not bisect the building. The clapboards and the chimney cap, however, match those of the newer section and are read as replacements. Earlier clapboards of a different width (diminishing in size from bottom to top) can be seen on the south facade. On this same side one can see that the two innermost bays contain identical doorways which are probably original. Interior evidence can be found which supports three different interpretations of this plan and unfortunately none is conclusive. The bilateral division of space and nearby farm structures set off from the earlier main house suggest the possibility of a duplex tenant house for the Rider farm. That the halves are not exactly equal plus the existence of the German double entrance dwellings in nearby Pennsylvania and Western Maryland (upper Baltimore County is Northern Maryland and very much a part of that unique culture) it is possible that this house was a single family dwelling with separate entrances for the formal and everyday areas. The proximity of the building to the railroad, however, plus the evidence of a hotel in this neighborhood and the earlier "chopped up" quality of the second floor raise the possibility of this structure having had a semi-public use.

At any rate, on the interior the following was observed. The first floor plan provides for a parlor on the east side of the chimney and a kitchen on the west, while the second level contains two bedrooms. There

is some evidence that these two rooms at one time were divided by partitions. The interruption in the random width flooring in the northwest corner indicates that there may have been access from the kitchen below.

In the basement, what appears to be brickwork rises above the floor frame in the north wall. A stone wall between the old and new sections is butt joined to the outer walls.




