DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house on 130 Church Lane is a rectangular two story framehouse with a gable roof. The original house has been altered to dwell three families. The top floor is an individual apartment as well as the one on the first floor and the later concrete block addition.

The front or north facade is three bays wide with central door and two 1/1 double hung windows on its first floor. There is also a one bay gabled roof porch covering the entrance door and supported by four wooden columns and balusters.

The second story of this north facade is three bays wide with a side door on the west side reached by the wooden railed side stairs, and two 1/1 double sashed windows. There is also a central brick interior chimney covered with cement.

The west side is one bay wide having only one very small 1/1 window towards the south side. It seems to be of later addition for there is none in the north side and it seems to be out of proportion with the rest of the fenestration of the house.

The later addition to the house (northeast side) is concrete and has a flat roof. On its north facade it is two bays wide with a four paneled wooden door on the west side and a 2/2 double hung sash window. There is no fenestration on the east side.

The back or south facade has two small 2/2 double hung windows. On this facade there is still another addition which comes out of the original building and seems to be a kitchen. It seems to be of a later addition as evidenced by the different asbestos shingles and the difference in styles.

It is important also because, being a framehouse, it is one of the typical construction techniques of the houses in the rural areas of Maryland. Yet another reason, is that it is an important component of the nineteenth century streetscape of this village of Texas.
