DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house located on 144 Church Lane , is a rectangular framehouse with a gable roof and exterior end chimney. The house is covered with green asbestos shingles resting on a stone foundation.

The front or south facade is three bays wide on the first floor and a central wood panel door. This first floor also contains a three bays wide porch with gable roof supported by wooden balauster type columns.

The second floor of this south facade is two bays wide with two 1/1 double hung windows. On the roof, towards the southwestern side, lies the interior end brick chimney.

This house has a shed roof addition facing the north side as evidenced by the concrete block foundation of the original building. The north side is inaccessible.
