DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This 2½ story brick house is five bays wide, two rooms deep, and faces east. A half-hipped, one-story porch with chamfered posts and scroll-work brackets and pendants spans the principal (east) facade. The central entrance has a paneled surround with a simple transom and sidelights, and is flanked by floor-to-ceiling 2/2 sash windows. The second story have five 2/2 sash windows aligned over the openings below. All the aforementioned openings have flat arches. A central cross gable holds a 4/4 window set in a pointed arch. Brick is laid in stretcher bond. Two corbeled interior end chimneys rise from the ridge of the standing-seam metal roof.

The east (gable) facade has two 2/2 sash windows on the first and second stories, with two smaller sash windows lighting the attic. This gable is painted red.

A two-story ell extends to the rear. Southeast of the house stands a small 1½ story outbuilding whose novelty siding may conceal log construction.

This site is indicated as the residence of J. Wolfrom on J. Sidney's 1850 map of the city and county of Baltimore (Baltimore:James M. Stephens, publisher). Hopkins' 1877 atlas indicates this site as a tavern belonging to Henry Fringer.


