The Scott/Conrey House is significant as a well-preserved example of rural Queen Anne architecture, unusual in its area. It is 2-1/2-stories high, 2 bays wide, of frame construction, and faces north. Its plan and massing are irregular, but basically consist of a hip-roofed main block with cross gables running east, west, and north, with a 2-story gable roofed extension to the south. A small jerkinhead projection containing a 4-pane diamond window rises from the apex of the hip. Present siding is aluminum, with shingles and elaborate sawn and turned Eastlake ornament in the gables.

Research tends to support the local tradition that the house was constructed around 1894 by a member of the Callow family. In 1903 it was sold to rev. James Gibbons, Roman Catholic Archbishop of Baltimore, and served as the rectory for the nearby Holy Family Catholic Church until 1918, when it passed to the Conrey Family.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The house is 2 1/2 stories high, two bays wide, of frame construction and faces north. Its plan and massing are irregular, but basically consist of a hip-roofed main block with cross gables running east, west and north, with a two-story gable-roofed extension to the south. A small jerkinhead projection containing a four-pane diamond window rises from the apex of the hip. Present siding is aluminum, with shingles and elaborate sawn and turned Eastlake ornament in the gables.

The principal (north) facade has a projecting gable bay (three sided on the first floor) at left; the right bay contains the entrance, each bay at the second floor. A one-story porch spans the north facade and wraps around the east as well; its hipped roof has a cross gable with lattice-work detailing defining the entrance and is supported by plain turned posts and curving brackets with trefoil cutouts. Turned pendants are centered between the posts, and there is a simple balustrade. A shed roofed porch with similar detailing is found at the rear of the east facade; this has been enclosed with glass. Another glass-enclosed porch appears on the west.

The south facade has a two-story, three-sided projecting bay, with a gable roof which overhangs at the corners. On the west, fenestration reflects the placement of the stair, with a diamond window composed of multiple colored lights at the entrance, a 2/2 sash centered at landing level, and a pair of 2/2 sash of the second floor. A dentilled cornice extends around the building, and the eaves have a modest overhang.

## STATEMENT OF SIGNIFICANCE

The Scott/Conrey house is significant as a well-preserved example of rural Queen Anne architecture, unusual in its area.

Research tends to support the local tradition that the house was constructed around 1894 by a member of the Callow family. In 1903 it was sold to Rev. James Gibbons, Roman Catholic Archbishop of Baltimore, and served as the rectory for nearby Holy Family Catholic Church until 1918 when it passed to the Conrey family. The Callows, immigrants from the

Isle of Man, are significantly associated with the development of newspaper wire services in the United States.
