DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Ambrose House is located on flat farmland in central Long Green Valley (Hydes, Md.) on the west side of Long Green Pike and is numbered, 13016.

Exterior

The house is a mid-nineteenth century, one and a half story, three bay wide, Victorian frame structure. It sits on a stone foundation and is covered by a cross gable roof. The original clapboards and scrollwork on the eaves were covered over with asbestos siding and trim within the last ten years.

The exterior symmetrical appearance shows that this house was probably built originally to be a double house, which it is now. The features which display this symmetry are the two central interior chimneys, the two side porches and the two identical, four panel front doors; one on the south side and the other on the north.

The north and south sides are identical except for the screening added to the south side porch. Both sides have a one-story porch with a slightly hipped roof that extends the length of the side and is supported by six round pillars. At the first floor, porch level, there are three bays consisting of two, four over four sash windows and a central four panel door with a three sash transom. At the second floor, there are two bays consisting of four over four sash windows with rounded heads. The louvered shutters on the second floor have been removed but still remain on the first floor. Above the second floor, is the gable which consists of a 90° angle with a ventilation opening just below the peak. The north and south sides serve as the front entrances to each side of the double house.

The east and west sides were once similar until the rear (west) facade was altered with the addition of an enclosed back entrance to the north side apartment, a bulkhead, and a one-story, two bay wide kitchen addition to the south side apartment. The rear (west) facade is two bays wide on the second floor with modern, six over six sash windows. The east facade faces Long Green Pike and has three bays on the first floor and one bay on the second. The windows are all four over four sash with a rounded head on the second floor window. On the east and west sides, the gable consists of a 60° angle.

Interior

✓ The interior of the house is divided into two apartments, the north side apartment being one third of the south side apartment. The layout of the south side consists of a central hall plan with a double north and south parlor to the east of the central staircase. To the west of the staircase is one long room with a modern fireplace centrally located on the west wall. Off this room to the left of the fireplace is the kitchen addition. Most of the interior has been altered except for the trim in the parlors and the original front doors. The north side apartment also has a central hall plan but with only one room on each side of the central staircase.

STATEMENT OF SIGNIFICANCE

Ambrose House surrounded by open farmland is located in Hydes, Maryland in the vicinity of Long Green Valley and was built about 1872. It is significant as being one of the few examples of a double Victorian "Country Residence" type of house (similar to those designed by architect, John Riddell) in Long Green Valley. When it was first built, it was owned by Mary E. Gittings and James Gittings, her husband. In 1872, it was then sold to Robert Dilworth, then in 1886, it was sold to Benjamin Ady and then in 1892, it was sold to John T. Ambrose. Stories have been told that it was once two houses separated by a drive way and car port. Nevertheless, historical photographs of 1907 show it to be one house with only a fence dividing the two properties which extended from the east side of the house to what is now Long Green Pike. The original scrollwork on the eaves can also be seen from these photographs but was taken down within the last ten years.

Am sure I cd. not have done better, or in some cases as well. Wollon & Haile are both sticklers. Anyway, thanks again. Best,




