DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Shanklin's Store is centrally located in a commercial district of Long Green Valley (Glen Arm, Md.) on the west side of the bend in Glen Arm road. The address is 12062 and 12064, Glen Arm road.

Exterior

The house is an early 20th century, Victorian frame structure five bays wide with two and a half stories. It sits on a stone foundation and is covered with a cross gable roof. The original clapboards and trim have been covered over with asbestos siding and trim. The house is divided in half with a residence on the north end and an office on the south end.

The function of each half is most evident in the front (east) facade with the presence of a central chimney on the north (residence) side and two, probably original store front bay windows on both sides of the front door on the south (commercial) side. The front (east) facade has a one-story porch with a shed roof supported by five round pillars. A wooden railing surrounds the north (residence) side of the porch. The front door on the residence side is original with a three sash sidelight. The foundation is rubble stone and comes to the edge of the porch. To the south side of the house next to the porch, is a bulkhead. On the second floor of the front (east) facade are five, two over-two sash windows. Above the second floor is a gable wall dormer with one, two-over-two sash window with a rounded head.

Most of the south facade has been covered up by the one-story, eleven bay commercial addition. This addition resembles a motel with its many doors and windows. The only original features of the building still visible are the two attic windows, and one second floor window. The opposite north facade is entirely visible and has three windows on the first floor and two on the second and attic floors.

The rear (west) facade consists of a one-story, six bay wide addition, the length of the house with modern six-over-six windows. On the second floor, the original two-over-two windows still remain.

Interior

The interior has been altered and is inaccessible.

STATEMENT OF SIGNIFICANCE

Shanklin's Store is located in Glen Arm, Maryland at the bend of Glen Arm Road in the vicinity of Long Green Valley and was built about 1909 by Charles Russell. It is significant as being the only early 20th century example in Long Green Valley of a general store still remaining in Glen Arm. Across the street is what was once the Glen Arm railroad station. The area where the store stands was once a prominent location with this railroad station as well as many other commercial businesses such as a post office, a hardware store, a butcher shop, a two room school house, a large factory and the town hall.

The land on which the store stands was originally owned by Laura M. Beatty. In 1909, when the house was supposedly built, Laura Beatty sold it to William C. Piper who then sold it to George P. Isenock, who owned it from 1921 until 1927. In 1927, Joseph H. Giffen bought it and owned it until it was auctioned off to Stanley E. Shanklin in 1948. It existed as a store for about 68 years from about 1909 until 1977 when Mr. Shanklin sold it to the present owners. Through its entire existence it has always served for commercial purposes on the south side and as a residence on the north side. When it was a store it sold everything from penny candy to men's hats. Though a south wing was added about 1960, and many alterations made to the interior, the two original store front bay windows still remain.

Only Jenkins and George (m. Ellen Jenkins) owned the property
through Wm. Armour Jenkins who tore down the homestead in 1905
and built Remembrance.

chain of title meaningless
milestone is ordinary turnpike milestone
poor plan ... erroneous interpretation ... basic construction
not correctly identified -- orig. details not identified

title meaningless
mill not attached to house
mislocated on map


