The List house is a large squarish, brick, Colonial Revival structure, listed as new in the 1936 tax ledger, although it has the earmarks of the 1920s. The last dwelling on the east side of the only village street at the north end of town, it was built by Jacob Luther List, who had a large agricultural acreage adjoining on the east. The house is 2-½ stories. It has a full-width front porch, its hip roof supplemented by square brick columns. One dormer faces the street from the main hipped roof. The house is inconveniently close to a non-descript, concrete block structure located to the north, a former auto shop. The house has not worn well for its age, but is a prominent feature of the north end.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The List House is a 2½-story Colonial revival structure in brick, with hip roof, overhanging eaves, and one dormer facing the road. The house is three bays wide on the main facade at porch level, but only two bays across at the second story level. The main door is a solid, paneled type, protected by a glass storm door in a wooden frame. The main entrance is in the center bay. The house is square in the main block, laid out with a center hall floor plan. The main door is flanked on the north (left) by one double-hung sash window. On the south (or right) side of the door is a pair of double-hung sash windows. The windows are 2-over-2 types, the lights divided by central, vertical mullions. The house is two bays deep, window arrangement differing on the north and south sides.

On the north, there is a single stairway window midway between the bays, set at stair-landing level; the kitchen is supplied with twin double-hung sash windows with vertically divided lights. On the southside, the windows at the rear rooms are smaller, with twin, single-pane, double-hung sash windows at the first story, and one small, vertically divided, double-hung sash window at the second story.

The front porch runs the full width of the house, the hip roof supported by two square columns of brick. The porch is poured concrete, three steps above grade. The foundation is poured concrete, punctuated on the sidewalls by small rectangular windows of two lights each. A one-story frame addition runs full width across the rear of the house, with an entrance on the northside. This wing is covered with red composition shingle material.

The brick chimney rises through the roof at the rear of the house. The house brick is laid in common bond. Roofing material is light grey asphalt tiles. There are no shutters. The house is squarely aligned with the road and sits on high ground, astride the watershed line between two stream systems.

The house is inconveniently close to a nondescript concrete-block automotive shop, now closed, that is located immediately to the north and owned by the Maryland Line Volunteer Fire Department.
