The Standiford house is a plain, vernacular style, two-story plus attic frame duplex typical of a turnpike town, roofed with sheet metal, covered with white composition shingles. It was probably built by or for Howard T. Standiford who acquired the lot in 1885 and is found in the 1896 tax ledger with a frame house. W. Scott King took title in 1912, and following his death, in 1920, the house was described as deteriorating. The house was later refurbished, covered with composition shingles. The house has double front doors, and a full width front porch. The porch posts are decorated with scroll brackets, the only applied decoration on the house.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Standiford house is a plain, vernacular style, two-story plus attic frame duplex typical of a turnpike town. It is covered with white composition shingles, roofed with sheet metal that is painted black. The house is four bays wide, its double front doors paired in the inner bays to produce side-hall floor plans. The doors are paneled, protected by glass storm doors in aluminum frames. The main facade windows are all 6-over-6, double-hung sash types. The porch is full width, its deck a step above grade, very close to the highway, the porch roof is shed-roofed, covered with sheet metal painted black. The five square supporting posts decorated with scroll brackets, the only applied decoration or extra touch on the entire house. The main block is punctuated on the north by one small, 1-over-1, double-hung sash window set in the gable peak, the other a 6-over-6 window at first-story level, located closer to the rear of the house. The south end of the house is punctuated by similar gable and first-story windows as the north facade.

The rear wing is flush with the north or left side of the house and is a very low, two-story structure, shorter than the main block. The upper windows in this two-bay deep wing are very small in format, with 1-over-1 lights. The lower windows are 6-over-6 in layout; a concrete-block chimney rises between the two bays and towers over this low gable-roofed addition.

The main roof is gabled, with a pair of inside end-chimneys, decorated with corbelling. The eaves overhang somewhat and there are visible eave returns.

The foundation is practically invisible, with the wall covering material reaching down almost to the ground. The cellar is reached by slanted doors opening into stairs located on the southside of the house.

The court authorized trustee Newton D. Allen to sell the property, and he sold to Jacob F. Mealey in 1920, securing \$1,000. (8) Before settling the estate, the 1918 tax ledger showed Mrs. Hannah C. King as administratrix with:

Subsequent owners were Harry Gruel and Mary E. Gruel, who purchased from Mealey in 1937; and Joseph T. Kearney and wife, who acquired in 1944. (10) Ramsey V. Gemmill, owner of the property to the south, took title in 1979.

This house was at some point covered with composition shingles.


