The Miller Cottage is a smart looking frame Dutch Colonial house of two stories plus attic, now used as a real estate office. It was built just north of the Odd Fellows Hall in 1927 or shortly before by Howard Leonard Miller, a local truck driver, who accumulated a number of town properties, including the lodge hall. The house has a gambrel roof, combined with a full-width shed dormer; also a full-width front porch, and aluminum wall covering. The front door is centrally located, suggesting a center hall floor plan.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Miller cottage is a smart-looking Dutch Colonial house of two stories plus attic, recently refurbished as a home office after having reached a neglected condition. It has a gambrel roof that opens into a full-width, shed-roofed dormer on the east or street facade, providing openings for three double-hung sash windows of 1-over-1 format. These windows are equipped with both solid shutters and awnings.

The front porch is full width, and its roof is an extension of the main gambrel roof of the cottage. There are four square supporting posts, now enclosed in aluminum siding. Segmental arches shaped from the same aluminum material span the spaces between columns. The main door is in the middle, suggesting a center-hall plan. The front door contains six glass lights and is protected by a contemporary metal storm door. There are pairs of contiguous sash windows on either side of the door, their lights 1-over-1 in format, equipped with solid shutters. The porch is two steps above grade, its deck wood, its one outside step of brick.

On its south end, the cottage is three bays in depth, allowing two full-scale windows at the second-story level, plus a square attic window centered between them near the peak of the roof. The first-story windows on the sides are in three bays: the first bay west of the street contains a single sash window; the second bay contains a pair of contiguous sash windows; and the third bay contains a small window, set high in the wall. All side windows other than the one for the attic are equipped with louvered shutters.

The north end is two bays deep. The bay nearest the street contains a one-story bay window with its own hip roof and a 1-over-1 window. The rear bay contains a small sash window; at second-story level, there are two normal 1-over-1 sash windows.

The chimney is centrally located, rising through the rear roof slope. The entire house is sheathed in white aluminum siding. Roofing material is blue-black rubber tile. The foundation is not visible.

STATEMENT OF SIGNIFICANCE

This Dutch Colonial frame house has all the earmarks of a 20th Century structure and its origin is more easily demonstrated by following successive entries in the tax ledgers than by tracing the deed, which became enmeshed in a much larger three-acre parcel that was several times conveyed back and forth and in and out of the Miller family.

The 1923 tax ledger shows that R. C. Myers sold to H. Leonard Miller 3/4 acres on the westside of York Road in the village of Hereford and it was an unimproved tract worth \$115. (1)

The next tax series shows that Leonard Miller had a dwelling worth \$2000 on his parcel, a garage worth \$75, and "other buildings" worth \$25. (2)

Miller was son of the blacksmith, S. Howard Miller, and he was described as a truck driver in court testimony after his death. During his lifetime, he accumulated a number of properties, and after the Jehovah's Witnesses moved out of the former Odd Fellows Hall on the lot to the south, he purchased that building.

Miller died at age 67 in 1968 and his affairs were somewhat complicated by lawsuits and by court rulings that some of his conveyances had been null and void. The testimony proved at least that the Dutch Colonial was his residence; one witness mentioned a "contract to sell the former home of Howard Leonard Miller immediately north of Kingdom Hall." (3)

The Miller heirs sold to James L. Dent and wife in 1971. (4) The Dents conveyed to Harry C. Pullen and wife in 1976. (5) The house has been considerably improved and renovated and is in use as a real estate office.


