Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*  
 The Mays-Tarbert Tenant House is an example of a late 19th or early 20th century 3-bay, 2-1/2 story weatherboard building. The house's placement in relation to the road and the main house reflects its status as a less-important dwelling than the main Mays-Tarbert House. The Tenant House is on the east side of York Road, separated by the highway. However, this was a typical arrangement of the tenant's dwelling. Together with the main property to the west, it demonstrates the standard layout of an early twentieth century agricultural complex. As such, it is eligible for inclusion in the National Register of Historic Places under Criterion A, Maryland's agricultural history. It should be noted that the house is not individually eligible, but a component of the larger Mays-Tarbert Farm property (BA-921).







This rectangular, frame, two-story tenant house was built in the early 1890s per its owner, who resides in the large Queen Anne house on the opposite side of the road. The house is perched on a high bank caused by road grading. This was the only dwelling charged to Charles H. Mays in the 1896 tax ledger, and apparently was the Mays family residence while the mansion was being built to replace an earlier main dwelling. The Mays family owned this ground in whole or part from 1845 to 1837. The present owners, William L. and Barbara Tarbert, took title in 1957. The house is plain, covered with clapboard, with a stone foundation and gable roof. Style is vernacular.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Mays-Tarbert Tenant House is a late 19th Century replacement of an older structure, more vernacular in style than Victorian. It is frame and clapboard, two stories plus attic, three bays wide by two bays deep, gable-roofed, with a central entrance and center-hall plan. The house is perched fairly high above the road, partially due to extensive highway grading. It is set in a spacious location, partly surrounded by agricultural land, partly by the open space around Hereford High School which is the property to the north.

The front door is paneled, with six small glass lights; it is flanked on each side by a 1-over-1, double-hung sash window. The full-width front porch is shed-roofed, three steps above the high ground on which the house is built. Four round, decoratively turned wooden posts with scroll brackets support the porch roof. The porch is protected by plain wooden rails without balusters or vertical members.

There are three windows across the main facade at second-story level, similar to those on the floor below.

The roof is gabled, its ridge aligned with the highway. Undecorated brick inside chimneys rise at each end of the house. Roof eaves overhang on the ends. The end walls contain a typical window in each of the two bays at both stories. Two square, 2-over-2 attic windows open in the gable peaks.

The foundation is stone, painted white. This tenant house has always been separated from the main dwelling by a public road, but the grade reduction of recent years has made it more isolated. By any reckoning, this is the farthest north outpost of historic houses on the eastside of York Road at Hereford.

STATEMENT OF SIGNIFICANCE

This house on the eastside of York Road, the first dwelling south of Hereford High School, has long been part of the farm across the road. It is apparently the replacement of a house shown in the same spot by the 1850 map and the 1877 atlas. The present owner believes that the house was built in the 1890s at about the time the main house of the estate was built. Apparently this house or its predecessor was the only residence available to Charles H. Mays in 1896, because the tax ledger that year shows him owner of a tenant house worth \$200, but without a main house. The adjoining properties listed that year were John Knight and Edward Burton. (1)

By the time of the 1911 tax ledger, there were two tenant houses, assessed at \$300 and \$100 respectively. (2) In 1918, there were two tenant houses:

Ten. House #1	16 x 22	2 stories	\$396	
Ten. House #2	14 x 40	2 stories	168.	(3)

The Mays family had been owners of this ground in whole or in part since 1845, but in 1937, it finally passed out of the family to George C. and Mary C. Ensor. (4) The owners of the tenant house have been the same as those across the road. Present owners are William L. and Mrs. Barbara Tarbert, who took title in 1957. The acreage acquired by the Tarberts was much less than that held by the Mays family, due to losses caused by construction of I-83 to the west of the main house.


