This house seems to be a replacement of one of the first generation of town houses. The lot changed hands in 1897 for \$325, when the ground itself would have been worth about \$50. Arthur Arnold who kept the adjoining county store was the purchaser in 1897. John G. Mays was the next owner, taking title in 1898. Between 1911 and 1918 the assessment had jumped from \$400 to \$869, and the house had apparently been enlarged. The 1915 State business directory listed Mays as a huckster.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Mays house is a small, two-story, plus attic, vernacular style duplex house, set close to the road and close to the ground. There is a full-width, shed-roofed front porch, the roof supported by wrought-iron columns topped by iron scroll brackets—fairly recent improvements. The porch deck is concrete, flush with the sidewalk. The house is five bays wide at first-story level, with its two doors located in bays two and four counting from either end. The doors contain large glass lights and are also protected by contemporary glass and metal storm doors. The windows at this level are 6-over-6 double-hung sash types with louvered shutters. The four windows at second-story level are irregularly spaced and three of them are 6-over-6 types, but the window directly above the southernmost front door is abnormally large in comparison to the others, with 1-over-1 lights.

The shed and gable roofing is covered with black asphalt material. The centrally located chimney is of white brick, a contemporary replacement, rectangular in cross-section, rising between halves of the house, emerging through the roof ridge. End rafters of the gable roof overhang only slightly.

The south end of the house is three bays deep. One bay is under the gable peak of the main block. The other two bays are in a flat-roofed rear wing.

The first bay contains a single, 1-over-1 window at first-story level, none at the second, and a casement window of six lights at attic level; both windows have louvered shutters—shutters being somewhat unusual in attics. The two rear bays contain a side door sheltered by a hood supported by brackets—that in the middle bay; the other three positions for fenestration are fitted with 1-over-1 sash windows, also with shutters. The side door is paneled, reached by field-stone steps.

The north end of the house is practically blank, with only one 6-over-6 window at first-story level (with louvered shutters) and a square window of four panes at the gable peak.

The house is covered with a grey asphalt or rubber siding material printed in a pattern of long, narrow bricks.

The foundation becomes visible toward the rear of the house. This structure has enjoyed a considerable amount of repairs which make it bright in appearance and very livable, but it has lost the look of a frame house of a country town.

STATEMENT OF SIGNIFICANCE

The present Mays house was once part of the same parcel that includes the delicatessen structure to the south, but all evidence suggests that the old general store structure was put up during the ownership of Daniel Yost, probably between 1873 and 1886. But tax lists and sale notices prove that there was only one large domestic building on the tract and it doubled as Missinger's Tavern; the tavern is known to have been demolished in the 20th Century. At the time of the 1896 Tax Series, Mrs. Mary H. Batchelor of Hereford owned a frame store building and a "Log Dwelling" that only reached \$50 in assessed value. (1) Some twenty years earlier, the house and lot had been rated at \$550. (2)

Clearly, the present structure is a replacement that could easily be mistaken for one of the cluster of house symbols on the maps of 1850 and 1877.

In 1897, Mary H. Batchelor and her husband, William L. Batchelor, sold the present house parcel, some 97 square perches, to Arthur Arnold; they were the keepers of the store and held the store lot for another year. (3, 4) The property changed hands for \$325 at the 1897 sale and for \$390, when Arthur Arnold and wife sold to John G. Mays. (5)

The house was assessed at \$400 in 1911 and, in 1918, at \$869, so that it had apparently grown considerably when owned by the Mays family. The dimensions given in 1918 were:

The 1915 Polk State directory showed J. Grant Mays as a "huckster," and the tax list showed that he owned two horses. (8) In 1950, John G. Mays and wife, Lula A., deeded to Grant M. Mays with the proviso that they would receive life care, clothing, and medical attention. (9) This is apparently a late replacement structure for one of the building blocks of the original town core, but it fills out the streetscape, which in Hereford is beginning to suffer gaps from lost buildings.




