Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

This property consists of a two-story wood frame vernacular house constructed on a masonry wall foundation and a barn. The side-gabled house has a full-width shed roof porch and measures four bays by two bays. There is a detached 1-1/2-story garage apartment in the rear. There are metal double-hung sash (4/1 lights) windows and the roof is clad by composition shingles and the house is clad by vinyl siding. The rectangular barn has a standing seam metal gable roof, with a louvered roof ridge ventilator cupola, and is clad by corrugated metal.

According to the MIHP form completed for this property in 1980, the house was built between ca. 1848 and 1850. The form indicated that the house surveyed in 1980 had a cross gable, however no feature was evident in the building; the low-pitch roof appears to be a later addition. This property appears to retain little of its architectural integrity and does not appear to be associated with any significant individuals or events in Hereford's history. This property appears to be not eligible for listing in the National Register of Historic Places.



KELLY-HAMILTON-COLE HOUSE

Ground-rent records would suggest that a structure was built on this lot after 1848. This structure may be the J.D. Patterson house shown on the 1850 sidney map. It was probably one of the houses crowded onto the 1877 atlas plate. The 1896 tax ledger proves that Franklin P. Kelly owned this house. Later owners were William E. Hamilton and later J. Emory Cole and wife. This is a frame, Victorian style, cross-gabled, two-story duplex house, four bays wide with full-width front porch. The cross-gable has no windows in its peak. Porch roof supports are contemporary wrought iron columns. Roofing is standing-seam tin. The entire structure is covered with white aluminum siding.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Myers House, alias Kelley-Hamilton-Cole House, is a two-story Victorian, cross-gabled duplex house, four bays wide, with a full-width front porch. The arrangement of the doors is not balanced, the doors being found in the first and third bays from the north end, which produces two half-houses with side-hall plans. The doors are paneled at the bottom and have large, single-sheet glass panes in the upper half. The doors are protected by contemporary glass and metal storm doors.

The main facade faces west. All windows on the main facade are 2-over-2 double-hung sash types with louvered shutters. The porch has a shed roof of standing-seam tin; roof supports are contemporary wrought-iron columns.

The main roof has a cross-gable facing the street, but there is no peak window. The main roof is also standing-seam tin. There is a brick central chimney, also a concrete block outside chimney on the south end of the house.

The south end wall of the main block is almost unfenestrated, with only one window in the first story rear.

A one-story shed roofed rear wing also presents a single window along the south end.

The north end of the house contains one 2-over-2 double-hung sash window at first story level, located on the center line of the main block; two small attic windows of four panes each are the only other fenestration at this point. No windows open from the rear, shed-roofed wing.

Foundation is stone, not visible on the main facade but partially exposed on the south end.

The entire house has been covered with white aluminum siding, which had obscured some of the original wooden elements.

STATEMENT OF SIGNIFICANCE

This house stands on one of the large lots of Hereford Resurveyed, laid out in 1843 by surveyor Enoch Dorsey for Nicholas Merryman. (1) Since these lots were subject to ground rents, it is somewhat difficult to determine whether a house stood on the property. Two lots here were acquired by James D. Patterson in 1848 under lease. (2) Two years later, the 1850 map by J.C. Sidney showed a house owned by J.D. Patterson who in 1861 assigned his interest in the property (i.e., the structure on the leased land) to Dr. Robert Kerr and William Kerr. (3) Patterson had to execute a confirmatory deed to the Kerrs in 1863 because the original document had burned in the courthouse fire at Towson. (4) The unspecified improvements on the ground sold for \$500, which could have been a modest house. When the Kerrs assigned their interest in the lease to Andrew Marsh in 1865, they accepted \$250 in return. (5)

This house seems to be one of the unbroken series structures indicated at the south end of town by the 1877 atlas.

Following a lawsuit in 1891, the Merryman family interests in the land itself were sold and passed to Franklin P. Kelley. (6) Kelley was charged with a frame dwelling worth \$350 in the 1896 tax ledger. (7) The next year Kelley and his wife sold to William E. Hamilton, subject to the operation of the lease. (8) The property was shown as that of Minnie and Edna Hamilton in the 1918 tax ledger with:

Dwelling 16 x 36	2 stories	\$685
Barn 26 x 30		280
3 Outbldgs		100. (9)

In 1921, the Hamiltons conveyed to J. Emory and Rebecca Cole. (9) In 1927, the Cole bungalow was built on the property to the south, a lot now assigned the street number 16,829 York Road. In 1949, Lawrence Vance Cole and wife sold to Hensel L. and Bertha I. Phillips, who held five years and sold to Orville E. and Beulah I. Myers. (10) Champlain S. Packard became owner in 1964 and sold to Glen H. Myers and wife in 1973. This cross-gabled Victorian house seems to date from the early period of town development in Hereford.


