Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Grupy Hollow building is a survival of the tanyard once conducted in the valley of Broad Run called Grupy's Hollow or Bell's Valley. Possibly the stone structure was always a residence but it is built in a very plain country style from rust-colored local stones. The main block is 1½ stories and faces into the meadow or valley. It is set very close to Belair Road but screened from traffic noise by a thick stand of bamboo. There is a small frame extension to the north forming an L-shaped footprint. Down in the meadow is a ruined spring house of the same type stone as the present Schmidt residence. In an old style rural tanyard, there would have been many shallow vats lined with stone walls; the bottoms of the vats would have been packed earth or sand. To date, no Maryland tanyard has been excavated.

In what seems to be a confirmatory deed made in 1850, there is proof that there were two generations of Grupy's, Francis H. Senior, and Junior. The elder Grupy was deceased as of 1850 and his property was in the immediate vicinity of Kingsville and commonly known as Grupy's Tanyard and being the same land on which the said Francis Grupy lived to the time of his death."⁴

The Sun reported that F. Grupy sold his farm and tanyard to E.J. Bell & Brother, ship carpenter, in late 1853 or early 1854.⁵

Grupy moved his operation to the fringe of Baltimore City. In 1859, a letter to the editor of the county paper reported of the "Hide Oil and Leather Establishment of F.H. Grupy,"

...my friend some five years ago was quietly located on his little farm and at work at his little tannery in Baltimore County...

then Grupy moved to South and Water Streets in the city and marketed sole leather.⁶ The tannery trade name was Grupy and Stansbury in the 1856 Gazetteer of Maryland.⁷ The foul smelling end of the business was listed on Greenmount Avenue in an 1864 advertisement.⁸

The Bell family engaged in routine farming and the county paper in 1890 reported a surprise party for Anne Bell held in "Bell's Valley."⁹

One of the family members who lived in Montana published a genealogical book about the Valley in the 1980s.¹⁰ During the 1970s, John Henry Miller was using the tanyard building to assemble Tiffany glass windows made to order for various private and corporate customers. About that time, Mrs. C.J. Langenfelder found a millstone in the meadow and had had it moved up the hill to serve as a garden decorated near her 20th century Colonial Revival house. However, we can not account for any grain mill at Broad Run and U.S. 1. The companion millstone has yet to be found.

There have been suggestions that the building was constructed by the Day family, owners of the former "Kingsville Inn" but John Paul, the owner in the 1798 tax list had no small stone outbuildings. The 1823 and 1824 Assessments of Old District 2 list the Kingsville Mansion, the home of Abraham King and also a Jacob Grupy (not Francis Grupy) "on the new Belleair road" with 10 acres and \$150 worth of improvements. The Thomas Todd family heirs owned the ground before the Grupy family as revealed in the deed to the Kingsville Mansion, WG 138:153 (1816). Thomas Todd's 200 acres of "Gassaway's Ridge" contained only \$15 worth of improvements in the 1823 Tax List of Old District 2.
2. Assessor's Field Book, 1841, District 11, Baltimore County, unpagged, Hall of Records, Annapolis. The oldest records spell the family name with one "P." as do deeds that copied family signatures.
