Located at 330 Church Road, Baltimore County, this two-story frame dwelling has an "L" shaped configuration with an intersecting gable roof. A center cross-gable with a rounded window 2/2 window exists on the main (south) facade. Modern alterations to the windows configurations, application of synthetic siding, chimney enlargement and the porch addition on the northeast corner reduce the historic integrity of this simple dwelling. Dating from the turn of the twentieth century, the vernacular dwelling is typical for the Owings-Mills/Reisterstown areas. Modern outbuildings such as metal tool sheds and greenhouse are situated to the north of the dwelling. Located on the north side of Church Road, the building has a moderate setback to accommodate the embankment of the road. Due to its common architectural features, the building does not display distinctive characteristics of type, period or method of construction. The surrounding neighborhood is a conglomeration of modern and other older vernacular dwellings. It also does not appear to be a component of a historic district because of the considerable infill construction from the 1960s-90s. This office concurred with the consultant's determination that the England property was not eligible for the National Register.

Red Run Boulevard will only impact the setting of the property.

The England House is a rectangular, two-and-one-half story, three bay frame house with ell. The house has a side gable roof and center cross-gable with a round-arched window in the gable peak. There are two interior, brick end chimneys. The one on the west gable end has been enlarged with stucco. A new patio/deck has been added on the main, south facade. There, the center door has been replaced, a grille has been attached on the front and door "shutters" are attached on the sides. A filled-in porch/deck with sliding glass door has been constructed on the rear (northeast corner) of the house. Around the house are three modern sheds and a plastic-covered greenhouse. The property on which the house at 330 Church Road stands is part of a parcel known as *Clark's Part* patented in 1740 to Henry Clark. The five acre-parcel was acquired by Franklin W. Hanna in 1905, and the house was apparently built by him at that time. The house is a typical vernacular residence in the Owings-Mills-Reisterstown project area, and is characteristic of other nearby houses on Church Road and in Belltown at the turn of the century, when the area was composed largely of farmers and laborers. Influenced by the Gothic Revival style, it is a common form which has witnessed alterations on the main (south) facade of the house. The house is not unusual architecturally or historically.

7. Description

This is a rectangular, two-and-one-half story, three bay frame house with ell. The house has a side gable roof and center cross-gable with a round-arched window in the gable peak. The roof is covered with asbestos shingles. The cornice and the house walls are covered with blue-grey aluminum siding. There are two interior, brick end chimneys. The one on the west gable end has been enlarged with stucco. Double-hung, sash-type windows on the house vary, and some have been replaced. They include 6/6, 2/2, and 1/1 lights, and green shutters have been added to the windows and to the front door. A new patio/deck has been added on the main, south facade. There, the center door has been replaced, a grille has been attached on the front and door "shutters" are attached on the sides. A filled-in porch/deck with sliding glass door has been constructed on the rear (northeast corner) of the house.

Around the house are three modern sheds and a plastic-covered greenhouse. The area is landscaped and includes a variety of trees and flower beds. The house sits on a slight rise on the north side of Church Road.

8. Significance

The property on which the house at 330 Church Road stands is part of a parcel known as *Clark's Part* patented in 1740 to Henry Clark. In 1752, Clark conveyed the land to Edward Parrish, and it stayed in the Parrish family for another century until 1854, when it was conveyed to William Beam. Beam passed the tract to Peter Bail in 1867. Then a 45-acre tract, John Morrow and son acquired the land that year. In the 1880 agricultural census, John Morrow was shown to have a ten-acre farm valued at \$4,000, but it is not clear whether that included the parcel at 330 Church Road. After a suit in the Circuit Court for Baltimore County in 1884, trustees were appointed to sell the land. David L. Slade acquired the tract in 1885. Slade sold five acres to Mary and John T. Ford in 1894, and the parcel on which the house at 330 Church Road stands. In 1896, the Fords were assessed for \$30.00 per acre for the five-acre tract and for one horse, for a total of \$230.

The five acre-parcel was acquired by Franklin W. Hanna in 1905, and the house was apparently built by him at that time. The property remained in the Hanna family throughout the twentieth century. Harriet E. Hanna, granddaughter of Franklin W. Hanna, married George C. England, Sr. The Englands own the property and live at the house today. The structure at 330 Church Road does not appear on any nineteenth century historic maps of the area.

The house at 330 Church Road is a typical vernacular residence in the Owings-Mills-Reisterstown project area, and is characteristic of other nearby houses on Church Road and in Belltown at the turn of the century, when the area was composed largely of farmers and laborers. Influenced by the Gothic Revival style, it is a common form which has witnessed alterations on the main (south) facade of the house. This house is similar to the ones at 402 Pleasant Hill Road and 410 Church Road. The house is not unusual architecturally or historically and does not merit inclusion to the National Register of Historic Places under Criteria A, B, or C.




