

CAPSULE SUMMARY

Anderson Acres, at 525 Earl's Road, was constructed circa 1890-1895. The house is set on a hill on the west side of the road. Large paddocks are located to the east and south of the house, and a line of vines and shrubs marks the western boundary of the property. Following the tradition of the farmhouse, mature trees provide shade around the house. According to the occupants, the dwelling at 525 Earl's Road was originally a log cabin, although no visible physical evidence remains at the exterior to prove or disprove this.

The main block of this Queen Anne-style dwelling, constructed in two stages, is two stories in height and three bays in width; the southern two bays predate the northern one. More recently a one-story extension with a standing seam, metal, shed roof was erected to the south of the main block. The wood frame house is clad in German siding with a board and batten gable end at the south elevation. A brick chimney with a corbel cap rises above the side gable roof, and two exterior chimneys, one brick and one parged, rise at the rear of the house. A one-story, four-bay porch with wood posts extends across much of the facade. A number of outbuildings are scattered across the property.

EXTERIOR DESCRIPTION:

The main entrance to the house is currently located within the east elevation, the facade of the house. Located within the one-story addition, the current primary entrance is marked with a single-leaf, panel-and-light door. The center bay of the two-story section historically served as the main entrance to the house and is also marked with a single-leaf, panel-and-light door. The remaining bays at the first story are pierced by replacement 1/1 aluminum windows. The second story is marked with three 2/2 windows, one in each bay. All window and door surrounds are flush with dog-ears.

The north elevation is two bays in width. A single-leaf, panel-and-light door with a gable roof hood is located in the eastern bay at the first story. A single 6/6 window marks the western bay at the first story and each of the bays at the second story. All window and door surrounds are flush with dog-ears.

The west elevation of the house is pierced only at the one-story addition with a pair of sliding metal windows.

The south elevation of the house is pierced only at the one-story addition with two 1/1 windows. Both window surrounds are flush with dog-ears.

OUTBUILDINGS:

Directly east of the house is a large icehouse that dates from the construction of the house. Typical of the building type, the majority of the icehouse is submerged in the ground. The wood frame building is covered with an asphalt shingle, gable roof.

To the south of the icehouse is a small privy that dates from the turn of the twentieth century. The wood frame privy is clad in vertical board siding and covered with a metal, shed roof with exposed rafter ends. A paneled door is located at the east elevation of the privy.

To the south of the privy is a 1930s concrete block workshop. The workshop is covered with a side gable roof, and the facade is pierced with a panel-and-light door and with a fixed 4-light window.

South of the workshop is a birdcoop, which also dates from the 1930s. The wood frame birdcoop is covered with a shed roof. A panel-and-light door provides access at the north end of the east elevation. A metal storage shed has been added at the north end of the coop.

South of the birdcoop is a 1950s guesthouse. The guesthouse is set on a tall concrete block foundation. The wood frame building is clad in asphalt shingles and covered with a gable roof.

South of the guesthouse is a second privy that also dates from the early twentieth century. This privy was clad in vertical board siding and covered with a shed roof.

To the east of the guesthouse is a large, wood frame barn that dates from circa 1910-1920. Set on a concrete block foundation, the board and batten barn is covered with a metal gable roof. Several frame shed roof extensions have been constructed to the west and south of the barn.

The house at 525 Earl's Road is typical of dwellings constructed in rural communities across the country in the last decade of the 19th century. A two-story, two-bay, side-passage dwelling was a common house form during this period, and adding a third two-story bay was a common way of expanding the building. Although minimal in detail, reflecting its rural setting, this modest dwelling incorporates features associated with the Queen Anne style. The style is exemplified in this dwelling through its slender proportions, corbeled brick chimney, and board-and-batten gable ends, which provided contrasting wall textures.

The modest dwelling was erected by either William Mace or Henry James at the end of the 19th century. The property on which the dwelling presently is sited was historically two individual parcels, hence the difficulty in identifying the original owner of the building. The death of Mace in 1889 leads one to believe the dwelling was constructed by Henry James, yet there is not documentation to substantiate this.

The first parcel, consisting of 52.5 acres, was purchased by Mace in 1882 from Oliver Tennison. Florence Mace Putnam, et al inherited the property in 1889, retaining it until 1948. The land was then sold to Thomas Casson. The second parcel, consisting of 71 acres, was purchased in 1870 by Henry M. James from Thomas Fouble. It was conveyed in 1898 to James E. Debouler, who subsequently sold it to Robert Cook Appleby. During the next few decades, the property was sold numerous times, until Thomas Casson purchased it in 1948.

Combining the two parcels today designated as 525 Earl's Road, Casson subdivided the land and transferred 53.88 acres of the tract in 1951 to his ex-wife Bernice S. Casson. Designated as Bonnie-Vale in the plat books, the property was sold by Casson in 1964.

It was conveyed three times hence until November 7, 1986, when it was purchased by the present owner Theodore and Joan C. Thomas.

National Register Evaluation:

The house at 525 Earl's Road is not eligible due to the fact that it does not meet National Register Criteria A, B, C, or D. Preliminary research has not revealed any association between the dwelling and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in our past (Criterion B). Although the building provides an example of the Queen Anne style, it is neither unusual nor distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). There is no evidence that the property is likely to yield information important in history or prehistory (Criterion D). Thus, the property is not National Register-eligible.


SKETCH MAP
