

The cemetery of the German Reformed Church or First Evangelical and Reformed Church is an enclosure behind and west of the frame church building on the west side of Jarrettsville Pike in the north part of Jacksonville's "Four Corners." The cemetery is enclosed by fencing of stone posts and metal pipe. There are numerous memorial stones, some fairly tall made of black polished granite. This cemetery was brought to the attention of the LPC in 1997 by local citizens. However there is no sign of neglect and the grass was obviously mowed during the 1997 growing season.

The small frame chapel at Jacksonville was built in 1888 under the corporate title of the First Evangelical and Reformed Church. Three trustees acquired a fragment of the once gigantic "Clymalira" manor from Louis Ahrens and wife of York County on October 11, 1887. The trustees called the congregation the German Reformed Church in the deed. The original board consisted of John Conrad Lins, George Lintz, and John Zinkhan, who paid \$145.31 for the ground located on Meredith's Ford and Jarrettsville Turnpike Road. 1

Mrs. Shirley Clemens of Monkton informed us that the first minister served the church from Immanuel German Reformed Church in Baltimore City. The Lintz family were immediate neighbors of this church as shown in the Bromley atlases, and one of the prominent polished black monuments in the cemetery is that of the Lintz family. The C. H. Lintz house just south of the church was opened as the Manor Mischief Antique Shop on October 4, 1997.

This church closed in the 1970s and its records and assets were transferred to the Chestnut Grove Presbyterian Church on Sweet Air Road east of Jacksonville; the building was used as a Sunday School and for Youth Fellowship meetings for a time. The hand-marked map in the "house numbers" office of Baltimore County shows the former church as "GNA Club Senior Center."

In December 1994, the Chestnut Grove Presbyterian Church sold the property to Walter M. and Regina Ratterman of Phoenix. In 1996 a plan was developed to convert the structure to business use. A certain amount of restoration was evident in late 1997 but no business seemed to be conducted in the building. The owners' attorney informed the LPC staff on January 22 that the office conversion needed a DRC waiver, which would be heard February 2. The cemetery and grounds were in good condition, the grass apparently having been mowed the previous season.
