DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Mettam Memorial Baptist Church is located on the south side of Old Court Road between Reisterstown Road on the West and Park Heights Avenue on the east.

The church is one and one half story structure measuring thirty by forty feet. The lime and sand mortar was patched with cement in 1965-1966 during a renovation of the property by the Pikesville Lion's Club. The church is three bays long and three bays wide. The principal entrance door located on the central bay of the north facade is recessed from the exterior surface of the sixteen inch thick walls. The recess and the double door is paneled. A rectangular stone lintle exists above the five light rectangular transom. The east elevation has a paneled door in the northern most bay, while the west elevation has one window in each bay. The southern gable facade has two windows at the end bays and no opening in the central bay. A second set of two windows was placed with the sills parallel with the lower windows. The higher window frames are set toward the center and touch the shutters of the lower set. The windows of the church have six over six sashes and three panel shutters. The stone lintles are in three pieces the center of which, is shaped to resemble a keystone. The church has a plain box cornice along the east and west facades which paralled the ridge of the roof.

The interior originally consisted of one room. In the mid-1960's renovation a partition was added to contain heating facilities and other conveniences. The plastering, the paneled doors and simple window frames and the floor are all original.

The church sits on an acre of ground which includes a cemetery.

STATEMENT OF SIGNIFICANCE

SEE INSTRUCTIONS

The Mettam Memorial Baptist Church is the oldest ecclesiastical structure in Pikesville and was one of the original congregations in the area.

The church was constructed in 1835 a year before the congregation joined with five others to found the Maryland Baptist Union Association. This group evolved into the Baptist State Mission Board of Maryland, the state organization of the church. The structure's importance rests in its historical associations with the Baptist Church in Maryland. In 1964 a historic society was formed to assure the preservation of the church. It's simple architectural features echo the fundamental principals of its builders.

In 1966 the Pikesville Lions Club preserved the structure and provided with an adaptive use as a distribution center of legal documents and books for developing nations. Today it serves principally as the monthly meeting place for the board.

Notes on alterations and additions

The building has been restored during 1965 and 1966 to as nearly as possible to its original state. The interior has been changed to include a small room at the back of the building. This partition allows for heating equipment, toilet facilities, and a work room.

HISTORICAL EVENTS CONNECTED WITH STRUCTURE

This is the oldest ^{church} building in Fikesville. It was used as a community meeting place as well as a church from 1835 until about 1935. Since that time the congregation has moved away and for quite a few years the building was not kept up. A movement in 1964 has resulted in a special historical society to keep alive the historical significance of the building. This was one of the six churches to assist in forming the Maryland Baptist Union Association in 1836. This is the significant thing about the building that its congregation helped to form our present state convention--Baptist Convention of Maryland.

The pastor in 1835 - Joseph Mettam continued as the pastor until his death in 1888.




