DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Lloyd House is a stone house set into the hillside, three storeys in height on its principal southerly side, two on its northerly; the storey at grade on each side is three bays in length, a door flanked by 6/6 windows with louvred blinds, and the upper storeys are two bays in length. Windows of the third storey are 3/3 without blinds. Masonry above openings is supported by plain wooden lintels. A one storey porch extending the length of the house shelters the ground storey on the south side and another shelters the middle storey on the north. Single-flue chimneys of brick rise above each gable end, flush with the stone walls below. The metal covered roof extends over the eaves and rakes with a moderate, plain overhang.

This traditional house probably dates from ca. 1850-1870.

The interior was not accessible for inspection.

Immediately east of the dwelling is a two storey, one-bay-square stone outbuilding, the lower storey probably a dairy house, the upper a smoke house. Board doors into each storey are centered on the south side, into the lower storey, and on the north, into the upper. Small boarded-up windows are in each storey's east and west wall.

East of the house and its outbuilding is a frame blacksmith's shop, one storey in height, four bays in length; exterior walls are sheathed in board-and-batten. The small windows are trimmed with plain boards, the head trim slightly raked.

STATEMENT OF SIGNIFICANCE

This modest dwelling with its stone outbuilding and frame blacksmith shop dates from the 1870's. It was built by Daniel Brooks and inherited by his widow and children. It is presumed that this was a tenant house and that the present George Canoles house (q.v.) was probably the family dwelling of Mrs. Sallie Brooks shown in the 1877 Hopkins Atlas. The 1896 Baltimore County tax shows that the Brooks family owned two stone dwellings, a loz smith shop, stone stable, a wheelwright shop and a frame building described as a store with a hall, all at Belfast. In about 1860, about one half an acre of their land was sold to the county for the Belfast schoolhouse, which is still standing just west of this house.

The Lloyd C. Felton House is a two and one-half story rubble stone house with a datestone at the top of the east gable inscribed as follows:

T.R.BOND
1849
T.S.MASn

It is the only datestone in the district giving the initials of the mason. The house and outbuildings were part of Thomas Bond's large real estate holdings. His son, John Bond, bought it in 1877 and sold it in 1883.

North of the house is an octagonal ice house with rubble stone walls and is an example of the polygonal shapes for buildings which were advocated by the architect Orson S. Fowler, who was also ~~the~~ author of A Home for All which was written in 1853.
