Woodhall Farm was originally called Belle Haven. It was built by James Mason who purchased the property in 1802 from his father-in-law, Abraham Scott. This is the sturdy dwelling of a prosperous, but unpretentious farmer. The two remaining outbuildings, a stone dairy house and a stone root cellar, are indicative of the many structures once required to support rural life. The vaulted underground root cellar is not uncommon in Baltimore County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Woodhall Farm is a two and one-half storey stone house, three bays in length with a gabled roof and a flush end chimney at its west end; its principal facade is to the south. A modern frame wing, also three bays in length but slightly lower than the original, extends to the west and a modern one storey garage wing extends to the east. The dimensions of the original house are approximately 29½ feet (east-west length) by 30½ feet (north-south depth). Few details remain visible to indicate the date of this house; the interior has been completely refinished with new detailing throughout. The 6/6 window sash are set within wide plain frames all of modern date, but the dimension of the latter suggest the earlier existence of wide frames. Sills are of worked stone and stone lintels are less regular. The crown moulding of the north cornice is of the typical early cyma-recta above cyma-reversa profile, again suggesting an early date. The sawn oak roof rafters are half-lapped and pegged at the ridge and a hand-made nail is visible in one of them. A few original first floor joists and a massive central hewn girder remain in the cellar and some contain random hand-made nails driven in as hanging hooks.

The principal entrance is through the easterly bay but the back door, which has been made narrower, is in the central bay. The two chimneys (which meet as one in the attic storey) and the massive girder in the cellar indicate the house to have always been

STATEMENT OF SIGNIFICANCE

This sturdy dwelling, located on the east side of Wheeler's Lane, was the home of a prosperous, but unpretentious farmer. James Mason married Rachel Scott, the daughter of Abraham and Elizabeth Scott whose home and mill was at "Regulation" (q.v.). He bought from his father-in-law sixty acres of land in 1802 and built this substantial home. Belle Haven, as it was originally known, was located on the 1795 patent to Abraham Scott and the name persisted into the twentieth century.

In his book Tidewater Maryland Architecture and Gardens, Henry Chandlee Forman dated this house as "probably soon after.....1780."¹ However, the 1798 Federal Direct tax shows no stone dwelling of the dimensions of Woodhall; thus it is presumed that James Mason erected the dwelling after he bought the land in 1802. The present owners indicate that the major alterations were effected by their uncle, Allen C. Davis, when he purchased the structure in 1934.

two rooms in depth. The entrance sidehall extends only to the dividing partition between the two westerly rooms allowing a small northeasterly room in each storey. The open stairway, all of modern construction, rises with winders at the top within the sidehall, probably in its original location.

A few interior door architraves from the house are stored in the barn consisting of two planes with a cyma-reversa-with-astrigal backband.

A small one storey gabled roof stone outbuilding stands south-east of the house; its appearance suggests it was a dairy-house although no spring or nearby well is apparent; internally modern finishes obscure original work. A door is slightly south of center in its west end and a wide low window is in its south side; its east end and north side are void of openings. It measures approximately 13 by 15 feet.

Northeast of the dwelling is a one-storey gabled roof stone structure sheltering stone steps down into an underground stone-vaulted root cellar with internal dimensions of approximately $7\frac{1}{2}$ by 11 feet.
