This vernacular house is located near the historic village of Black Rock (now Armacost) and is associated with the town of Hampstead in the Fifth District of Baltimore County. The Fifth District is located in the northwest corner of Baltimore County and is historically known for its abundant waterpower and timber that spurred construction of sawmills, paper mills, and flour mills, making this an industrial region of the county. Although an exact date of construction for the house has not been determined, historic maps and architectural evidence support a circa 1860 date. The house appears on the 1877 Hopkins Atlas as being occupied by A.A. Armacost.

Built circa 1860, this two-story dwelling is sited in a rural landscape on a level grassy lot. It has foundation plantings and is surrounded by many mature and immature trees and shrubs. A paved driveway leads to the house. The wood frame house sits on a solid parged stone foundation and is re clad with German vinyl siding. The original house has an L-shaped foot print with a one-story shed roof addition in the angle of the ell. The façade of the original house is pierced with six 6/6 double-hung wood sash windows. A canted bay window holding two 6/9 double-hung vinyl sash and one fixed 40-light vinyl window has replaced the original doorway. A two-story three-bay lateral addition maintains the front entrance to the house. The house has two exterior-end brick corbeled chimneys that are shouldered. One interior-end chimney has been removed from the original house. A shed roof porch covers the first story of the façade of the lateral addition. A one-story open hyphen connects the two-story addition to a one-story separate wood frame kitchen. The kitchen has a front gable roof covered with standing-seam metal and one exterior-end parged brick chimney. The kitchen is two bays wide with one 6/6 double-hung wood sash window and one single-leaf flush wood door. It sits on a solid parged foundation, has overhanging eaves, a boxed cornice, and is re clad similar to the house. One historic garage and one non-historic shed are associated with this property.

Built circa 1860, this two-story dwelling is sited in a rural landscape on a level grassy lot. It has foundation plantings and is surrounded by many mature and immature trees and shrubs. The original house has an L-shaped foot print with a one-story shed roof addition in the angle of the ell. The façade of the original house is pierced with six 6/6 double-hung wood sash windows. A canted bay window holding two 6/9 double-hung vinyl sash and one fixed 40-light vinyl window has replaced the original doorway. A two-story three-bay lateral addition maintains the front entrance to the house. The house has two exterior-end brick corbeled chimneys that are shouldered. One interior-end chimney has been removed from the original house. A shed roof porch covers the first story of the façade of the lateral addition. A one-story open hyphen connects the two-story addition to a one-story separate wood frame kitchen. The kitchen is two bays wide with one 6/6 double-hung wood sash window and one single-leaf flush wood door. It sits on a solid parged foundation, has overhanging eaves, a boxed cornice, and is reclad similar to the house.

Built circa 1940, is a concrete parged garage standing one story high and three bays wide. The façade holds two roll-up paneled wood doors and a single-leaf flush metal door. The foundation is not visible and it is capped with a side gable roof covered with standing-seam metal.

A log shed sited to the rear of the house appears to have been constructed circa 1980. It is one story high and one bay wide with an overextending front gable roof covered with asphalt shingles. It has v-notching, one vertical board door, and one exterior-end concrete-block chimney.


