The William A. Burke Store was historically located in Upperco in the Fourth District of Baltimore County. In 1870, the district had a population of 4,167. Although an exact date of construction for the Burke store has not been determined, historic maps and architectural evidence support a circa 1840 date. It first appears on the 1850 Sidney Atlas as Andrew Burk's store. Located along Hanover Pike, this wood frame house appeared as the William A. Burke Store on the 1877 Hopkins Atlas. The 1915 Bromley Atlas denotes J.F. Armacost at this residence. Hanover Road (later Hanover Pike) is a continuation of the Baltimore and Reisterstown turnpike into Pennsylvania. Serving the Village of Upperco was a local post office, tavern, store, and several churches, the St. Paul's Methodist Church and the St. Paul's Lutheran Church.

Standing close to Hanover Pike, this L-shaped two-and-a-half-story dwelling is surrounded by several mature trees and shrubs and sits on a sloping grassy lot. A paved driveway leads from the road to the rear of the house. The first story of the façade is entirely blocked from view by vegetation. This wood frame building, dating circa 1840, sits on a solid random rubble foundation, is clad with German weatherboard siding, and is five bays wide. The house was built in three different periods including timber frame, log, and balloon frame sections. The façade has a total of nine 1/1 double-hung wood sash windows and one single-leaf wood oval-light replacement door on the façade. The windows and door have thin wood surrounds and sills, and the house exhibits cornerboards on each section. Covering the first story across the full-width of the façade is a shed-roof porch supported with three Tuscan wood columns and three square wood replacement posts. One interior-end corbeled brick chimney, and two interior corbeled brick chimneys rise above the standing-seam metal cross gable roof. The roof features molded wood cornice with returns, overhanging eaves, and a wood fascia board. The rear elevation shows a one-story shed roof addition, a wood frame addition with a shed roof sits below ground on the rear elevation. Six historic outbuildings are associated with this property; a shop, one shed, chicken coop, barn, corn crib.

Standing close to Hanover Pike, this L-shaped two-and-a-half-story dwelling is surrounded by several mature trees and shrubs and sits on a sloping grassy lot. A paved driveway leads from the road to the rear of the house. The first story of the façade is entirely blocked from view by vegetation. This wood frame building, dating circa 1840, sits on a solid random rubble foundation, is clad with German weatherboard siding, and is five bays wide. The house was built in three different periods including timber frame, log, and balloon frame sections. The façade has a total of nine 1/1 double-hung wood sash windows and one single-leaf wood oval-light replacement door on the façade. The windows and door have thin wood surrounds and sills, and the house exhibits cornerboards on each section. Covering the first story across the full-width of the façade is a shed-roof porch supported with three Tuscan wood columns and three square wood replacement posts. One interior-end corbeled brick chimney, and two interior corbeled brick chimneys rise above the standing-seam metal cross gable roof. The roof features molded wood cornice with returns, overhanging eaves, and a wood fascia board. The rear elevation shows a one-story shed roof addition, a wood frame addition with a shed roof sits below ground on the rear elevation.

Six historic outbuildings are associated with this property. First, a shop, circa 1930 in good condition, stands one-and-a-half-stories in height and one bay wide. It is wood frame clad with pressed vertical board siding and sits on a replacement solid concrete-block foundation. It is illuminated with one 6-light wood awning window. The entrance contains a single-leaf wood paneled door. The asphalt shingle front gable roof features exposed roof rafters.

One outbuilding is a shed from circa 1920 and in poor condition. It rests on a raised random rubble stone foundation and is clad with board-and-batten siding. It is one story high and one bay wide with a single-leaf board-and-batten sliding door. The shed roof is covered with standing-seam metal and exhibits exposed roof rafters.

Next is another shed from circa 1920 and in poor condition. It is wood frame clad with vertical board siding with a single-leaf vertical board door. The exposed roof rafters are capped with a front gable roof sheathed with asphalt shingles. It does not have a foundation. The side elevation shows a 6-light wood awning window with wood louvered shutters.

A circa 1920 chicken coop is wood frame clad with weatherboards. It does not have a foundation and the façade shows three missing windows, one 6/6 double-hung wood sash window with the glass missing, one open bay, and one single-leaf bay with the door missing. This chicken coop is in poor condition. It has a shed roof clad with standing-seam metal with overhanging eaves.

Next, is a circa 1930 wood frame corn crib standing one story and one bay wide. The entrance contains a single-leaf vertical board door. It sits on a concrete block foundation, and has cornerboards. The side shed roof is clad with standing-seam metal.

Finally, there is a bank barn dating circa 1850. It is wood frame clad with board-and-batten siding sitting on a solid stone foundation. A high drive constructed of stone leads to an entrance containing a vertical board sliding door. There is a second entrance with a single-leaf wood door with a 10-light transom. The side gable roof is covered with standing-seam metal. A concrete block milk house constructed circa 1940 is attached to the dairy barn.

The Fourth District is located at the western edge towards the center of the county bordering Carroll County, Maryland and contains the largest area of land in the county. It is historically known for its Railroad transportation connecting to Pennsylvania, iron ore mining, and wheat farming. In 1870, the district had a population of 4,167. 

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The frame house at Arcadia Farm is 2 1/2 stories high, five bays wide by one bay deep, and faces east. It is clad in novelty siding, with standing seam metal covering its gable roof. The principal (east) facade has the entrance in the central bay, flanked on either side by two 1/1 sash windows. Five 1/1 windows are arrayed across the second story, aligned directly above the first-floor openings. The two southern bays are widely separated from the remaining three, suggesting that they may represent an addition. A one-story, shed-roofed porch supported on tapered colonial revival columns spans the facade. The cornice is boxed, with short returns at the gables and a plain frieze. A two-story, three-sided bay projects from the south gable; above this, two four-pane casements light the half-story. A corbeled brick interior end chimney rises from the north gable..


