The Lee House is located near the historic village of Bacon Hall and is in the Fifth District of Baltimore County. The Fifth District has very few towns and its population is sparse compared to other neighboring districts. It covers over 47 square miles and is bounded on the west by Carroll County, on the north by the Sixth District, on the east by the Seventh and Eighth Districts, and on the south by the Eighth and Fourth Districts. In 1881, it had a population of 2,241. During the late 19th century, this area was considered a highly industrial section of Baltimore County, due to its numerous saw-mills, paper-mills, and flour-mills. Not evident on the 1877 map, this property does appear on the 1915 Atlas, however, it is not noted with any owner.

Facing west away from the road, this vacant dwelling is sited in a rural landscape on a level grassy lot surrounded by mature and immature trees and shrubs. This L-shaped Second Empire-style dwelling, is wood frame reclad with composition shingles and sits on a solid random rubble foundation. It stands two-and-a-half stories in height and five bays wide. Covering the center three bays is a one-story flat roof porch supported with Tuscan wood posts and square balusters. Originally, there were eight window openings on the façade featuring 6/6 double-hung wood sash windows. Currently, four of the windows are boarded over. The attic story is illuminated with three gable dormers each containing one 6/6 double-hung wood sash windows and sunburst ornamentation in the pediment. The central entry contains a single-leaf wood paneled door, as well as the center bay on the second story. Two interior-end parged brick chimneys and one interior-end brick chimneys rise above the mansard roof. The roof is covered with asphalt shingles and features overhanging eaves and cornice returns. Located on the side elevation is a two-story wood frame addition. Associated with this property is one wood frame house constructed circa 1880.

Facing west away from the road, this vacant dwelling is sited in a rural landscape on a level grassy lot surrounded by mature and immature trees and shrubs. A paved driveway leads to the house. This L-shaped Second Empire-style dwelling, is wood frame reclad with composition shingles and sits on a solid random rubble foundation. It stands two-and-a-half stories in height and five bays wide. Covering the center three bays is a one-story flat roof porch supported with Tuscan wood posts and square balusters. Originally, there were eight window openings on the façade featuring 6/6 double-hung wood sash windows. Currently, four of the windows are boarded over. The attic story is illuminated with three gable dormers each containing one 6/6 double-hung wood sash windows and sunburst ornamentation in the pediment. The central entry contains a single-leaf wood paneled door, as well as the center bay on the second story. Two interior-end parged brick chimneys and one interior-end brick chimneys rise above the mansard roof. The roof is covered with asphalt shingles and features overhanging eaves and cornice returns. Located on the side elevation is a two-story wood frame addition.

Associated with this property is one wood frame house constructed circa 1880. It stands two stories high and three bays wide resting on a solid random rubble stone foundation. It is clad with board-and-batten siding and was illuminated with five double-hung windows, which are missing. The center entry contains a single-leaf cross-braced wood door. It is capped with a side-gable roof, which is clad with corrugated sheet metal. Two interior-end brick chimneys rise above the roof. The house features pedimented lintels, a two-light transom over the door, overhanging eaves, and a one-story side-gable roof addition.


