Circa 1800 - South bank of Big Gunpowder Falls, 30 feet upstream of power line. Foundations of large stone gristmill that accompanied Gunpowder Iron Works. Advertised as functioning in 1863. Reported as being remodeled in 1879, but not mentioned when the city offered the site for sale as surplus property in 1880. Possibly one of the asterisks shown in 1789 post road map by Christopher Colles.


