Located on the east side of Joyce Lane north of Western Run Road, this traditional village style dwelling was erected during the last quarter of the 19th century for Mrs. Sophia Jessop. She had purchased the land, part of the Regulated Vineyard Resurveyed, in 1880. The present house may have replaced an earlier structure which is shown on the 1877 Atlas of Baltimore County and the 1876 tax assessment; however, architectural research indicates that it is definitely represented on the 1896 tax assessment. By that time, it had been sold to the Joyce family which gave its name to the short road connecting the old Western Run Turnpike with the village of Davisville on Belfast Road.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Pindell House is a two storey frame house, five bays in length with a gable centered in the roof of its principal (west) front. Extending east behind its north end is a rear wing two bays in length with a two storey shed-roofed addition against its south side, probably replacing a one-storey shed-roofed porch. The principal front has no porch but one undoubtedly existed originally. The gabled roofs extend over the end walls, with rake cornices rising above bold eave returns. Exterior walls are covered with aluminum siding. Single-flue brick chimneys rise internally at each end of the main house; a similar chimney at the east end of the east wing has been removed. Typical windows are 6/6 with narrow beaded frames and louvred blinds; the principal entrance, centered on the west front, consists of a single door.

The interior of this late 19th century house was not examined.

The stone walls of a former small barn remain northeast of the house. The absence of a south wall suggests that the barn was a bank barn, its taller framed loft storey supported on three stone ground storey walls.
