## DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Oregon's present physical appearance is a demonstration of Nature's power of reclamation and restoration of trees, shrubs and flowers. The mine is now a 5½ acre lake eighty feet deep surrounded by trees, shrubs and flowers. The Country Store is in good repair, (now being used as a dwelling). The property is traversed by Oregon Branch, at one time a well-known Baltimore County trout stream, which empties into Loch Raven water supply. The property comprises 442 acres of woodland and agricultural land. The trees are 2nd and 3rd growth mixed hardwoods. There are many colonies of pink Ladyslippers, wild azaleas and mountain laurel. The Ore spoils banks are now forested in a predominance of unusually large Locust trees calipering in some instances 18" in diameter.

The lake area, now used for swimming, lends itself to even greater use as an income producing outdoor amphitheater.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Probably, Captain John Smith was the first white man to discover iron ore in Maryland. In 1608 he entered the Patapsco River which he named Bolus because of the red clay he found there. He sent two barrels of ore back to England to be examined.

In 1648 Plantagenet found iron ore in Baltimore County.

Demand for iron during the Civil War brought a temporary boom. The principal Maryland furnaces established after the Revolution were Oregon, erected 1849, abandoned 1857; Ashland Iron Works located near Cockeysville. Ashland Iron Works smelted iron from Oregon because they could smelt it more economically. Iron was hauled from Oregon in wagons drawn by six mule teams during the 70's. The Company ran from 8 - 10 wagons, each making 2 to 3 trips per day. Mining by hand from an open pit, workers loaded a small cart which was pulled out of the pit by steam power. The main ore pit at Oregon is now filled with water creating a lake of 5½ acres, 80 feet at its deepest point. This lake is now being used by the Department of Recreation and Parks of Baltimore County for recreational purposes.
