DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Riley's Store is a one story frame structure, its gable end facing west, close to the Falls Road in the middle of Butler. A one-story shed-roofed porch extends across its west end and a similar, but lower, addition extends across its east end, joining it to the Butler Post Office, a smaller frame structure, three bays in width, facing the combined parking lot to the north. The store's west front is in three bays, consisting of a door flanked by 6/6 windows, the latter with louvered blinds. The store's depth is expressed as two long bays, each with a small, high window. Exterior walls are covered with German siding and the low-pitched roof extends over all of them in a moderate, plain overhang. The store is said to have been built in 1902, a date consistent with its apparent form and details.

Internally it is a single room, its walls lined with wooden shelving.

STATEMENT OF SIGNIFICANCE

The Butler Store was erected in 1902 by Josias Mallonee, a hotel keeper whose home and business adjoined it. (q.v.) This building has served continuously as a general store and the Butler Post Office has occupied space there for about fifty years. Prior to that time, the post office alternated between this location and the Gent Store on the opposite side of Falls Road.

In the early 1940's, a one-story addition was built in the rear to house the storekeeper. This has now been converted into additional commercial space.

As most general stores in rural communities, this one has always been a gathering place for the neighborhood.





Hereford Quadrangle




1998 Aerial Photo with plane
