**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Parker House is a two storey frame house, three bays in length, with a gable centered on the roof of its principal south-west front, hereinafter called its south front. Extending north behind its west end is a two storey frame wing, one bay in length. A one-storey shed-roofed porch extends across its south front and a two-storey shed-roofed addition is against the east side of the rear wing, the northerly half of its first storey being open as a porch. Single-flue brick chimneys rise internally at each of the three gable ends. The gabled roofs extend equally beyond all walls; the walls are covered with German siding. The principal entrance, consisting of a single door with transom, is centered in the south facade. Windows are 2/2; the 2/2 window in the front gable is arched.

The interior of this ca. 1890-1905 house was not examined.

The Parker House is an example of a very typical late 19th century rural or village house, simple and traditional in general design but with a prominent gable centered in the roof of its principal front. That feature, emphasizing symmetry and the principal entrance, originated in sophisticated 18th century residential design and it was reinforced by the 19th century Gothic revival.
