## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

10901 Falls Road is a two storey white frame gable roof house with a stone foundation and 2 corbelled interior chimnies. A finial tops each gable which in turn tops vergeboard. The windows have green shutters. The west facade, presently the front of the house is a later addition to the original house whose front facade faced south. The south facade of the original house is 3 bays wide with a first storey porch which has a door in the central bay flanked by a 2/2 light double hung window in the east bay and a modern replacement window in the west bay that originally housed a second door and a window. The 3 windows of the second storey have 2/2 lights and wood shutters.

The first and second stories of the east facade of the original house are windowless while there is one basement window.

The north facade of the original house has 2 basement windows and two 2/2 light double hung windows in the first storey. These windows have wood sills and wood pediments. The second storey is 3 bays wide, its 1/1 light double hung window in the central bay is surrounded by 2/2 light double hung windows in the east and west bays.

The west facade of the house is the 3 bay wide cross gable addition with a hipped roof porch with decorative brackets. The 2/2/2 light window encased in wood that occupy the north and south bays of the first story surround a wood paneled door with 3 sidelights and a 3 light glass transom. The second storey 2/2 light double hung windows have wood wills, and the central window also has a decorative wood pediment above it. There is a square 2/2 light window in the gable.

The addition's east facade is 2 stories high and 2 bays wide. Its windows have 2/2 lights, wood sills, and wooden decorative pediments above each window.

The north facade of the addition has 2 windows in the basement and two 2/2 light double hung windows in the first storey which have wood sills and wood pediments decorating the top of the window frame. The second storey is 3 bays wide, its 1/1 light double hung window in the central bay is surrounded by 2/2 light windows in the east and west bays.

To the south of the house located near the dwelling there is a small lattice work gazebo with a weathervane on its roof that houses a well pump and a storage bin.

To the northeast of the house there is a small wood flat roof garage that serves as the wood hobbyshop of the houses's owner, Mr. Maurice Long.

To the north of the house there is a gable-roofed board and batten stable that has been converted into a garage. It has a stone foundation and is two stories high and two bay wide. Its sash windows have 6/6 lights and are in wood frames. Many of them display wavy glass. This part of the stable exhibits post and beam construction and there is evidence of log joists. This stable appears on a Arnold family photograph dating from about 1875.

Attached to the west facade there is a one story shed roof addition with a cement block foundation.

## STATEMENT OF SIGNIFICANCE

10901 Falls Road is an excellent example of Victorian architecture. The original house which was probably built in 1875, was enlarged 15 years later with an addition to accommodate the needs of a growing family. This house has many Victorian decorative elements such as finials, vergeboard, cross gables, and a lattice gazebo. The present owner, Maurice L. Long was born in this house in 1894. The original part of the house remains virtually unchanged with the exception of a window replacing a door and the removal of the chimney. This house is presently one of three consecutive Victorian era houses on east Falls Road between Joppa and primary roads that gives present day America a visual evidence of what Victorian streetscape once looked like.


