

CAPSULE SUMMARY - HOWLIN BARN 'B' (CT-1056)

Howlin Barn 'B' is representative of barns constructed in pre-Civil War Calvert County. Consisting of a 24 x 40 transverse axis plan barn with an original shed on the south side, the barn is located on a sloping field on the edge of Smoky road in Huntingtown. Its historical association is not known. Both the barn and shed make use of re-used materials. In spite of modifications to allow vehicle access, original materials include vertical weatherboards attached with cut nails, and a shingle roof extant below metal sheathing.

7. DESCRIPTION CT-1056

Howlin barn B is located on the corner of Cari and Smoky Roads. The barn is reached by taking highway four to Lower Marlboro Rd., turning onto Mill Bridge Road and taking this to Smoky Road. This barn is scheduled to be demolished in order to develop the area. The ground that the barn is situated on has eroded greatly to the west, and slopes down on the east side. The barn roof is on a north-south axis. There is no farm or farm house that the barn is associated with. The pre-Civil War era barn measures forty by twenty-four feet and employs hewn timbers and fully mature machine cut nails in its construction. There is an original fifteen foot wide shed on the south side.

The barn is separated into five eight foot bays, and has a transverse axis plan, with doors centered along each facade. The barn contains ten rooms. Concrete blocks and large unmortared field stones support the frame. The posts are hewn and joined to the top plate with mortise and tenon joints with trunnels. Down braces, cross sill, and top plate are also hewn. The sill has been cut out in order to accommodate vehicle passage through the central aisle, but the eight-foot wide doorway appears original. Many of the timbers have non-sensical empty mortises, and appear to be re-used. The nails that are original to the barn construction are fully mature machine cut nails. A few unusual nails with a central "bulls-eye" marking are visible in the downbraces where they join the sill. The vertical wall siding that covers the exterior of the barn appears original. Consistent with its nineteenth-century date, the barn has no ventilation doors. The original wooden shingle roof is still in place under the metal roof that now covers the barn. The rafters are on four foot centers and rest on a flat false plate. King posts, windbraces, and three collars support the roof. Tier poles are separated by forty-three inches vertical distance. The poles down the central axis are separated by four feet. The re-used timbers have stud mortises and some wrought nails. This barn was probably largely built from the remains of an eighteenth century barn.

The bay divisions of the south shed correspond to those of the barn. The shed has no sill and is constructed of earth-fast posts. The nailing rails and other lower timbers are circular sawn and lighter than those of the barn. The upper timbers including the tie beams and rafters are hewn and pit sawn. There are no nails or nail holes in the barn rafters below their junction with the shed rafters so the south shed is probably original. It is likely that the lower portions have had to be replaced due to weathering over the years. The south shed has plain vertical siding with minimal ventilation. An original wooden shingle roof still remains under the metal roof.


8. SIGNIFICANCE CT-1056

This barn is architecturally significant as a member of the twenty-four by forty foot pre Civil War tobacco barn group found during this survey. It is also significant as an example of extensive re-use of timbers and materials from an earlier barn. The southern exposure of the shed appears to be the most frequent location of an original shed.


This barn also yields information regarding agricultural history in Southern Maryland. In February 1990, a tobacco barn survey was initiated in order to study the tobacco barns of Calvert County. Until fairly recently, tobacco was the most important farm crop of the county. More acreage was devoted to its cultivation than for both of the next most extensive farm products (corn and wheat). The barns and stripping houses related to this "Tobacco Culture" are widely recognized as the most common element on the rural landscape. These structures are also the most threatened, as the market for tobacco declines. They seem to have, at present, only limited capabilities for re-use. Many barns and stripping houses now stand empty. The purpose of this survey has been to gather information and document a wide sample of these structures before they disappear from the landscape.

This barn has been altered little over the years. The most significant changes have been the addition of a metal roof, the insertion of concrete blocks for support, and the rebuilding of the lower portions of the south shed. It is not apparently associated with any family or farm, so this portion of its history remains unknown to us.
