CAPSULE SUMMARY CT 1071

Fanny Gibson Barn 'A'

Located in the back yard of a nineteenth century house in the water front town of Lower Marlboro, this privately-owned barn is no longer used for curing tobacco, and presently houses yard equipment. This fact may make this the shortest use barn in Calvert County as the date "May 3, 1962" is painted above the door to the partially underground stripping room in the northeast corner of the barn.

Similar paint marks are found throughout the interior of the structure numbering each of the hinged, ventilation doors.

The barn is oriented on a east-west axis and measures 48 x 26 feet, with a double-aisle plan served by two double doors on the west and one on the east. A built-in ladder to the upper level(the roof of the stripping room) is located in the center of the barn. The fully enclosed, partially subterranean, concrete block stripping room fills the northeast corner of the barn. Construction materials and techniques are all modern and consistent with the painted date.

7. DESCRIPTION CT-1071

This barn is one of the several tobacco barns located in the back yards of houses in Lower Marlboro Maryland. Lower Marlboro served as a tobacco shipping town for many years. The house in front of it dates to the nineteenth century. The barn has an aisle plan measuring forty-eight by twenty-six feet. It has no exterior sheds. The axis of the barn is east-west, opposite axis from the road that runs in front of the house on a north-south axis (Lower Marlboro Lane). The barn is constructed of circular sawn lumber, wire nails, and has toe-nailed joints. There is date inscribed in color paint on the door to the stripping room "May 3, 1962". This may well be the date of construction.

The forty-eight foot length of the barn is divided into bays each measuring eight feet. Double doors ten feet wide are located in the southern half of the east and west gable ends. It contains twelve rooms. The frame is supported on concrete blocks. There are two aisles in the barn separated by a cross sill laid on the ground that extends lengthwise down the axis of the barn. The posts, down, braces, and nailing rails, are all circular sawn and toe-nailed with wire nails. The posts are labeled in the same color paint as the date above the stripping room front (F) and back (B), with numbers. There is a ladder to the upper levels of the barn (above the eave) built into the central aisle. Vertical wall siding with hinged ventilation doors on the north and south sides. The siding extends below the sill. The roof is standing seam metal. The rafters are on four foot centers and rest on a flat false plate. The plate itself is constructed of two by four inch wide boards toe-nailed together in an L shape. Three collars support the roof. The tier poles are separated by forty-five and one-half inches vertical distance.

A partially below, partially above ground stripping room of concrete blocks is built into the northeast section of the barn. It is accessed through a four foot wide door and stairs that descend to its lower level.

8. SIGNIFICANCE CT-1071

This barn is architecturally significant for a variety of reasons. The most important among these is its membership in the group of tobacco barns associated with domestic residences in the town of Lower Marlboro. The pattern of tobacco barns directly connected with residences and small parcels of land is unusual in the county and has not been seen elsewhere. The barn also provides us with a date for the construction of the stripping room and probably of the barn itself. This date is May 3, 1962. Since the structure is dated it can be used to interpret other similar barns that are not dated.

This barn also yields information regarding agricultural history in Southern Maryland. In February 1990, a tobacco barn survey was initiated in order to study the tobacco barns of Calvert County. Until fairly recently, tobacco was the most important farm crop of the county. More acreage was devoted to its cultivation than for both of the next most extensive farm products (corn and wheat). The barns and stripping houses related to this "Tobacco Culture" are widely recognized as the most common element on the rural landscape. These structures are also the most threatened, as the market for tobacco declines. They seem to have, at present, only limited capabilities for re-use. Many barns and stripping houses now stand empty. The purpose of this survey has been to gather information and document a wide sample of these structures before they disappear from the landscape.




