

CAPSULE SUMMARY - WHITTINGTON BARN B

Whittington Barn B is a privately owned barn located on a farm in the northern part of Calvert County adjacent to the Patuxent River. It sits in a level field at the bottom of a hill and is situated on an east-west axis. The barn is part of a complex of farm buildings which includes three barns and a farmhouse. This barn is of modern construction, built of circular sawn lumber and wire nails it is supported on a continuous concrete block foundation. It is an excellent example of the long, narrow, aisle-plan barn built during the mid to late twentieth century for easy vehicle access. Hinged ventilation doors are found in each bay, a feature also characteristic of the increased attention to air flow seen in tobacco curing practises in the latter half of the twentieth century.

7. DESCRIPTION CT-1088

The Whittington farm is located in northern Calvert County at the end of Yellow Bank Road. The farm house is on the summit of a hill. Below the house are the barns. A farm road curves behind the house and then downhill to the west where the barns are located. Whittington barn B is on the north side of the farm road. It sits on a level field at the bottom of the hill. The barn is situated on an east-west axis.

Whittington barn B is located adjacent and to the west of Whittington barn A. Two other barns are further to the west of barn B. Whittington barn B measures eight-four by twenty-eight feet and has an axial plan. There are two sets of double doors on both the east and west sides. It is a modern barn built of circular sawn lumber and wire nails.

Each of the bays in Whittington barn B measure twelve feet wide. The posts are supported on a continuous concrete block foundation. The posts are toe-nailed with wire nails and are circular sawn. The down braces, internal sill, and horizontal nailing rails are also all toe-nailed and circular sawn. The down braces are in each first bay from the gable end. Additional bracing is visible in the superstructure of the barn, consisting of X- braces in each aisle. These extend from the tie beams to below the second tier pole level. The barn has vertical wall siding with three hinged ventilation doors in each bay. The roof rafters are on four foot centers and rest on a flat false plate. The top plate is a small timber measuring only three by five inches. There are windbraces along each diagonal of the roof. The roof is covered with corrugated metal. The tier poles are circular sawn boards nailed to the internal horizontal rails that extend between the posts of the internal sill. These tier poles are separated by four feet vertical distance. The internal sill that extends down the axis of the barn in every other bay has posts set on concrete block piers. Horizontal rails extend between the posts in order to support the tier poles. The barn has no sheds.

8. SIGNIFICANCE CT-1088

Whittington barn B is architecturally significant as a representative of the long, narrow, aisle-plan barn built during the mid-late twentieth century in Calvert County. It could easily be entered by vehicles, and multiple hinged ventilation doors serve to control the aeration of the tobacco. Also typical of this type of barn is the internal bracing in the superstructure.



This barn also yields information regarding agricultural history in Southern Maryland. In February 1990, a tobacco barn survey was initiated in order to study the tobacco barns of Calvert County. Until fairly recently, tobacco was the most important farm crop of the county. More acreage was devoted to its cultivation than for both of the next most extensive farm products (corn and wheat). The barns and stripping houses related to this "Tobacco Culture" are widely recognized as the most common element on the rural landscape. These structures are also the most threatened, as the market for tobacco declines. They seem to have, at present, only limited capabilities for re-use. Many barns and stripping houses now stand empty. The purpose of this survey has been to gather information and document a wide sample of these structures before they disappear from the landscape.

Tobacco is still grown on this farm. According to one of the nephews of Mr. Whittington, this barn was built ca. 1960. It has had no significant changes or alterations.


